Description The Contractor shall furnish and deliver the materials listed in the Schedule of Items in this Appendix in accordance with the contract documents. The structures shall meet the requirements of this Contract, the Plans, the State of Maine, Department of Transportation, Standard Specifications, November 2014 Edition including, but not limited to Section 712.061 – Structural Precast Units and Standard Details November 2014 Edition as updated through advertisement, Supplemental Specifications, and Special Provisions including, but not limited to Special Provision, Section 534, **Precast Structural Concrete** (Precast Structural Concrete Box Culvert, Fabrication and Delivery).

Delivery The actual delivery date of the materials shall be determined by the project schedules and coordinated with the MaineDOT in conjunction with the Department’s Contractors responsible for installing the precast units. The Department foresees multiple Contractors, as each location may be bid separately. The delivery dates are expected to be between July 2020 and September 2020, unless otherwise notified. If construction on any of the subject projects is delayed and the precast units are not able to be delivered and installed, the Manufacturer shall store the precast units for the delayed project until a date not later than September 30, 2021.

The Manufacturer shall deliver the precast units to the project sites on a weekday (Monday to Friday) in coordination with the onsite Contractors who are installing the precast units. The precast units shall be delivered to these project sites by the manufacturer:

Location: Located on Norton Road, 0.04 of a mile northwest of Main Street.

MaineDOT in conjunction with the Department’s Contractors installing the precast units must give the Manufacturer a minimum of 7 calendar days’ notice of when each structure shall be delivered.

The Contractors who are installing the precast units shall be responsible for unloading each precast unit at or near the project site in a timely fashion. Any incidental materials needed to temporarily store the precast units at the project site shall be provided by the Contractor responsible for installation.

MaineDOT shall provide the Manufacturer with the contact information for the Contractors responsible for installation of the precast concrete box culverts upon award of the installation Contracts.

Invoices and Payments The Contractor shall submit an itemized bill to the Department for materials following delivery for approval and payment. At a minimum, invoices shall include the following information:

Invoice Date & Number  
Dates of Delivery

The Department will pay based upon the materials delivered at the prices bid and the invoices approved. Payments to the Contractor shall be full compensation for furnishing all labor, equipment, materials, services, and incidentals used to supply the materials under the Contract in a complete and acceptable manner, and for all risk, loss, damage, or expense of any kind arising from the nature or prosecution of the Work. The Department may withhold payments claimed by the Contractor on account of incomplete or incorrect invoices or materials that are defective or not in conformance with the contract.

Material Quality Materials and manufactured products shall be new unless otherwise specified, free from defect, and in conformity with the contract. If there is no applicable standard set forth in this Contract for a particular item, then the item shall be in accordance with industry standards prevailing at the time of bid. The Department has the authority to inspect all Materials and every detail of the Work. The Department may reject the finished product if any of the components do not comply with the specifications. The Department may reject materials not conforming to the Specifications at any time.

Liquidated Damages Except as expressly provided otherwise in this Contract, the Contractor shall owe the Department Damages in the per diem amount listed specified in Standard Specification, Section 107.7.2 - Schedule of Liquidated Damages for each Calendar Day that any portion of the Materials that are delivered after the delivery date specified in the Contract. This will be deducted from amounts otherwise due the Contractor. Permission for the Contractor to deliver the Materials after the Contract Delivery Date shall not waive the Department's rights to assess Damages.
