B) Compliance with Applicable Laws, Obtaining Permits, and Consultation Requirements

The Recipient is required to comply with national policy requirements consistent with 2 C.F.R. 4) Build America Buy America

The Build America Buy America Act, enacted as part of the Infrastructure Investment and Jobs Act on November 15, 2021, established a domestic content procurement preference for all Federal financial assistance obligated for infrastructure projects after May 14, 2022. The domestic content procurement preference requires that all iron, steel, manufactured products, and construction materials used in covered infrastructure projects are produced in the United States. This project is subject to two approved waivers of the Build America Buy America Act though its funding sources and funding contributions from the Passamaquoddy Tribe. These waivers include a full waiver of all non-compliant sourced items up to \$11,589,176 and a waiver on the full project for Manufactured Products as defined consistent with OMB regulations, 2 CFR § 184.3. We do ask that applicants track all purchases that would be subject to Build America Buy America requirements so we can track compliance with applicable requirements and waivers.
