MAINE DEPARTMENT OF TRANSPORTATION
DESCRIPTION OF STATE MAINTENANCE BOUNDARY LINES FOR

Falmouth, Cumberland, County, Maine

Beginning at a point on Foreside Road (State Route 88) at the Falmouth-Cumberland town line; thence, southeasterly via said town line into the waters of Casco Bay; thence, southwesterly via Casco Bay to a point southeast of Mackworth Island on the Falmouth-Portland town line; thence, northwesterly along said town line to the Falmouth-Westbrook town line; thence, northwesterly along the town line to Brook Road; thence, northwesterly along the town line to a point due west of the westerly extremity of Indian Way; thence northeasterly to the northerly terminus of Balsam Lane; thence easterly to the northerly terminus of Brookside Drive; thence, southeasterly to Blackstrap Road at a point 0.32 mile northwest of Brook Road; thence, southeasterly along the easterly right of way of Blackstrap Road to the intersection of Brook Road; thence northerly along the westerly right of way of Brook Road (both State Aid and local) to the Mountain Road; thence easterly along the northerly right of way of Mountain Road to the Gray Road (routes 26/100); thence northerly along the westerly right of way of Gray Road to Bella's Way (private).

Thence, northeasterly to the Winn Road at the Falmouth-Cumberland town line; thence, southeasterly along the Falmouth-Cumberland town line to Long Woods Road (State Route 9); thence, southerly along the westerly right of way of Long Woods Road to a point 0.70 mile north of the intersection of Middle Road, reference utility pole #J27; thence, southerly along the easterly right-of-way of Long Woods Road to the Bridge over Interstate 95; thence, southeasterly along the northerly right-of-way of I-495 to U.S. Route 1; thence, northerly along the westerly right-of-way of U.S. Route 1 to the Falmouth-Cumberland town line; thence, southeasterly via said town line to Foreside Road (State Route 88), the point of beginning.

Also, a section on Blackstrap Road (inventory road # 443) beginning at the intersection of Mountain Road and extending northerly 0.84 miles.

Also, a section on Middle Road beginning 0.38 mile northeast of Long Woods Road (State Route 9), reference utility pole #246 west side of road and extending 0.38 mile northeasterly to utility pole #261 west side of road.

Note: Bridges, if any, bisected by the compact-urban line are in the rural area.

*updated northeast boundary on Falmouth/Westbrook town line around townways

** included remaining section of US Route 1 south of Cumberland town line
