## **PUBLIC NOTICE REGARDING**

### **Disadvantaged Business Enterprise Program FTA Goal Methodology**

Notice is hereby given that in accordance with U.S. DOT regulation 49 CFR Part 26, the Maine Department of Transportation has established a DBE Program for disadvantaged business participation for contracts involving the Federal Transit Administration.

For FFY 2026-2028 (October 1, 2026, through September 30, 2028), MaineDOT has established an FTA DBE participation goal of 1.20% to be achieved through race/gender neutral means.

Interested parties may view MaineDOT's DBE goal-setting methodology for the next 30 days during normal business hours (8-4, M-F) at the Maine Department of Transportation, Civil Rights Office, 24 Child Street, Augusta, ME 04333-0016.
