#### **A. Best Practices Committee**

#### **B. Professional Development Conference**

- March 26-28, 2026, at Sunday River. Over 89 vendors. Recognition from Rep. Bunker re: vendor accommodations for Cancer Awareness in an already full vendor list.

#### **C. Education and Training Strategy Committee**

- UU-1 Carry over funding for Live Fire Training Facility FY on 2/25 around 10am. MFPSC Chair and MFSI Director Graves shared testimony. Confident that budget language will move forward.
- Changes to NFPA 1400 (New 2026 Standard) specific changes to 1402, 1403 standards for engineering live burn buildings – specific focus on engineering plans. MFSI will update Live Fire Burn Policy to the new standard by late summer/fall 2026, asking multiple agencies to review the policy.

#### **D. Recruitment and Retention Committee**

- Started fourth round of recruitment in high schools in Penobscot County. Local departments and high schools are very supportive. SOG is being prepared and will be shared in future meetings.

- Fire planning is ongoing with town Warden meetings and municipalities.

- LD2223 "An Act to Increase Funding for Construction Plans Reviews and Clarify Rulemaking Authority for Municipal Reviews of Development (adds 2-4 positions for plans review at FMO).
- LD 2173 Work Session/Public Hearing attended by Chair Brooks; FM spoke on fire safety concerns.
- LD2224 (from 131<sup>st</sup>) Ongoing working group.

#### **B. EMS Report**

- First case of Measles in Maine (highly contagious). Monitoring closely.
- The DEA created a rule for how patients handled medications. Offered education in December 2025 re: this regulation. Effective date of March 9, 2026. Has not opened registration for agencies in Maine. Maine can move from statute, to rule, to protocol, to be compliant. Maine will need to make some changes to be compliant but is given time during transition from this federal mandate.
- LD 2128 Restructure EMS Board (OTP)
- LD 2132 Trauma hospital registry update on technical language
- LD 2133 Work session on Community Paramedicine definitions (mirror to LD 2119) working together to receive payment for CP programs.

#### **C. OSHA/BLS Updates**

- State Plan Meeting – did not attend due to snowstorm. Will be attending next meeting to report any updates from OSHA. BLS will be a vendor at MFCA conference at the end of month.
