Notes from MIAC Advisory Board Meeting on 10/04/2021

The following in substance is a summary of the meeting and should not be viewed or treated as a literal transcription.

• It is important to note that although MIAC's Advisory Board is exempt from record keeping requirements pursuant to 1 MRS §403(6) we nonetheless maintain and publish them in the interest of transparency and clarity.

8:15 am- Tracy Collins begins meeting.

- Lt. Stevenson introduction.
- Introductions of all participating in meeting.

8:25- Audit

- Privacy civil rights civil liberties audit. Yearly.
- Audit process- Director, Dep. Director, and 2 board members; standing and rotating member.
 - o Johnston, Casavant, Feldman, Hughes
- Picked 10 MIAC reports at random, each board member picked 10.
- Review report. Conclusion.
 - Found nonconformance. No violations.
 - Feldman- MIAC is not known to many and people are amazed to its existence. He believes the audit is a good process.
- Casavant- also believes good process.
- Hughes' statement- believes it to be useful.
- Collins- concurs and asks anyone interested to be involved in next audit to contact her.
- Johnston- Conclusions-
 - 1) Recurring theme. Parr question. How long should information be retained.
 - Sankey- What are the true operational needs of the MIAC?





- Scott- Law enforcement archives all records however minor. Concerned for future issues that may arise.
- Johnston- Agrees. You have to defend action and inaction. Why did you do something is as important as why didn't you do something. Important not to make kneejerk reactions.
- Feldman- Agrees, has records that are 25 years old. Would make sense to keep records for MIAC.
- Collins- Is anyone able to articulate the counter argument.
- Casavant First amendment events. Is it better we keep the information or delete it? For those who acted in their rights. Better to keep. Maybe delete the name out in the future?
- Johnston- Retention schedules. Nothing for MIAC.
- Frey- Feel better if we have a public guiding document for maintaining information or delete. How is it kept or discharged?
- Collins- Helpful to have an understanding how other fusion centers have crafted their policies.
 - Casavant -Will try to obtain for review before next meeting.
- 1st amendment issue to be reviewed.
 - Everything will have a different value. Dashcam footage vs. protest information.
 - Believes other centers will have a special event policy that is not the same as others.
- 2) Discovery What comes in must go out.
 - Johnston- Law enforcement shouldn't be making decision of what's important. Should be DA. How does involve MIAC. – MIAC does provide information for cases/ investigations. It's not MIAC's responsibility regarding discovery. Those receiving information needs to provide to DA or AG.
 - Casavant? -Standard language on e-mails and anything pushed out to make clear.
 - Johnston- Met with some people involved in major crime unit. Discovery obligation stays the same, it's how it's shared/ handled for input.
- o 3) What our role is in any special event. Touched on in discussion of #1.
 - Collins- Since already covered we will come back once we've gathered information on policies from others.
- 4) Justifiable To be reviewed in Executive session.
- 5) Template- Should it be amended for question 9.
 - Refined to fit Maine's needs.
 - Johnston- Question 9 usually N/A or no. Records usually don't specify when information is no valid. Records are generally understood to be law enforcement sensitive. Information speaks for itself. Kept coming back to if this question is needed.
 - Sankey- Agrees with LT. Does not see a reason to keep it.





- Stevenson- Reason for question. Is that to ensure that it was being purged if required to be purged?
- Johnston- Doesn't recall that coming up in documents. Can only speculate. Is not a system we have where information is being purged? Believes that decision to disregard or not should be on the audience.
- Frey- At sometime this question was believed important enough to be put it. Should be kept in mind regarding retention of records. Doesn't not believe this should be part of the standard form.
- Scott? Agrees with Frey. If it provides no value, we should clean up the form and delete it.
- Johnston- Is it time to vote?
- Stevenson- Thinks it should be tabled until next meeting during discussion of retention. Not a major issue currently.
- Collins- Agrees best to table until purging policy is discussed. Believes it best to find out what the purpose of that question is in case we have a blind spot.
- #13- Relates to 1st amendment activity.
 - Johnston- Adding the word "solely." Did the record solely relate... Did that make it clearer?
 - Frey- What would be the difference between the questions. Is the purpose of having solely is to remove the mixed questions re: 1st amendment?
 - Johnston- Online comment that could be considered a threat. Take that threat and add with other activities. Yes to question 13 could cause concern but need further digging.
 - ? in addition to answering A&B doesn't know if adding the one word would be helpful.
 - Collins- Believes It intends to sweep in all of the records that trigger that 1st amendment activity. The purpose of B to answer that. Can see folks having problem excluding 1 amendment involved records. Solely might make it too narrow.
 - Feldman agrees with Collins.
 - Johnston no agrees good idea to cast a wide net.
 - Stevenson- Agrees with Collins. There to protect us and justify why we did something.
 - Collins- suggests hearing specific example in executive session.
- Making a change to privacy officer.
 - Johnston- Parr handles a lot for State Police. Being mindful of his roles deciding to go in different direction. Privacy policy will have to have changes made.
 - Scott- Should we fill that position with someone affiliated with Maine State Police?
 Looking for someone outside. Neutral objective viewpoint. It's about transparency and legitimacy.
 - Collins- Is there a timeline?





- Scott- Would like to see something happen in the next few weeks.
- A motion by Scott to adopt amendment to change appointment and update email. 2nd Feldman.
 - Motion carries by majority.
- Motion to move to executive by Collins. 2nd by Feldman
 - Passed by majority.

- Collins- Does anyone wish to make a motion to amend question 9.
 - $\circ \quad \text{None.}$
- Stevenson. Motion to accept audit report? Sankey moves. Collins 2nd.
 - Accepted by majority.
- Stevenson- New business
 - New analyst. Lauren Hrubowchak.
 - Cyber security- Still in process of looking for new person.
 - LD 12 passed.
 - Sankey-Likes to prepare in a way for future issues that may arise due to current climate in country.
 - Board members for audits.
 - Collins- Anyone interested in participating? Email Collins. Collins will reach out missing board members.
- Old Business-
 - Johnston- Proposed language change regarding board members terms to avoid replace complete board.
 - Terms. Except with regard to those members of the Board who are ex officio members, the terms of the members of the Board are three (3) years. The Colonel, in consultation with the MIAC Director, may stagger board members' terms in the interest of continuity. Each member is appointed for a minimum of 3 years; however, the Colonel may extend any member's term as long as her or his term does last longer than 6 consecutive years.
 - Sankey- Make a motion to recommend bylaws. Feldman 2nds.
 - Passed by majority.
 - Sankey offers to alter his term to aid staggering
 - \circ EMS involvement.





- Stevenson- To clarify. Extending some to 6 years while replacing others at 3.
 - Johnston- Yes. At discretion of Col.
- Collins- Other business.
 - Sankey- Wants to reiterate importance to prepare for impact of events occurring nationwide.
 - Frey- Unsure how to address people who may try to bring other issues to Maine. Believes
 - Sankey- Perpetual education of outside people on MIAC and it's reason and purpose. IE federally funded mandated.
 - Importance of media's role.
 - Involvement of outside civilly recognized person. IE ACLU
 - Johnston- Good steps have been taken to educate.
 - Advisory board is important part. Great vehicle to address concerns. More transparent then ever before.
 - Feldman- Needs to be somewhat to involve public and advise them of this board to provide protection of their rights. Only gets attention when media reports something is wrong. Wants to address in future.
- Collins- Moves to adjourn. 2nd.
 - Passes on majority.
