Currently, the Maine Department of Corrections has two small residential substance abuse programs. Those programs are housed at the Maine Correctional Facility (MCC) in Windham and the Mountain View Correctional Facility (MVCF) in Charleston.
		The two sites and programs house prisoners with either a custody level of Medium or Minimum given the facility security level. This exclusivity limits the access of Close Custody prisoners to participate in the Department's residential substance abuse programs. The support of funds from a Residential Substance Abuse Treatment Grant would allow the Department to develop, evaluate, and sustain a residential treatment for the Maine State Prison, which is the largest correctional facility in Maine and will support the unmet needs of offenders reentering into our communities.
		To sustain and fulfill the fidelity of a residential treatment unit, the proposed unit would be a dedicated housing unit delivering case management, discharge planning for reentry, substance abuse programming, educational/ vocational services, recreation services, and clinical services. The unit would be closed off to most of the facility except for family/professional visitation; medical services; and ancillary services not feasible for delivery within the proposed unit.

The Kennebec County Jail Diversion Collaborative will be a comprehensive approach to diverting people with substance use disorder or co-occurring disorders away from the criminal justice system while ensuring public safety. This collaborative will effectively weave existing diversion efforts into a more cohesive whole, based on two assumptions: jail diversion must occur at all intercept points in the legal system and full community involvement is essential for diversion success.
		The primary population to be served will be incarcerated individuals who have known substance use disorder or co-occurring disorders that will be reentering the community. On an ongoing basis, a Corrections After-Care Community Liaison (Liaison) will work with staff at the Kennebec County Correctional Facility (KCCF) to identify incarcerated individuals who are expected to be released in 90-days and who have known substance use disorder or co-occurring disorders that will be reentering the community.
		A database will be established and maintained by the Liaison to track potential candidates for re-entry after-care services at time incarceration or who have interacted with community diversion efforts in the past. Incorporating this process into the intake procedures at the KCCF will initiate a screening process that will prompt further assessment of mental health and substance abuse issues related to incarceration. These initial steps also include involvement with Maine Pre-Trial Services to maximize diversion efforts post-arrest. This service can be available to facilitate alternatives to incarceration if substance use disorder or co-occurrence has been identified.
