CALL TO ORDER

Chair Rumsey called the meeting to order at 0908.

INFORMAL CONFERENCES

On a motion by Stark seconded by Bushey, the CRC voted unanimously to go into executive session pursuant to 1 M.R.S. § 405(6)(F) for the purpose of discussing information pertaining to allegations of certificate holder misconduct, which information and records are expressly made confidential under 25 M.R.S. § 2806-A(10).

CASE RECOMMENDATIONS

Case No. 2024-057 On a motion by Stark seconded by Nichols, the CRC voted 4-0 to present this case to the Board and recommend that the Board grant a waiver to this BCTP applicant for being convicted of the Class D crime of criminal mischief.

Case No. 2024-058 On a motion by Nichols seconded by Stark, the CRC voted 4-0 to present this case to the Board and recommend that the Board grant a waiver to this BLETP applicant for engaging in conduct constituting the Class D crime of unlawful possession of scheduled drugs.

Case No. 2024-061 On a motion by Nichols seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board grant a waiver to this BLETP applicant for engaging in conduct constituting the Class D crime of unlawful possession of scheduled drugs.

Case No. 2024-033 On a motion by Bushey seconded by Nichols, the CRC voted 4-0 to present this case to the Board and recommend that the Board revoke the certificate of eligibility of this corrections officer for engaging in conduct constituting the Class E crime of unlawful possession of a schedule Z drug (methamphetamine precursor).

Case Nos. 2024-030 and 2024-036 On a motion by Stark seconded by Nichols, the CRC voted 3 in favor, 0 opposed, and 1 recused (Bushey) to present these cases to the Board and recommend that the Board take no further action against the law enforcement officers who were the subject of these complaints.

Case No. 2024-011 On a motion by Nichols seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board offer this corrections officer a consent agreement that would impose a 3-year probation for being convicted of the Class D crime of OUI.

Case Nos. 2024-066 and 2024-078 On a motion by Stark seconded by Nichols, the CRC voted 4-0 to present this case to the Board and recommend that the Board take no further action against the corrections officer who was the subject of these complaints.

Case No. 2024-049 On a motion by Nichols seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board take no further action against the corrections officer who was the subject of this complaint.

Case No. 2024-050. On a motion by Stark seconded by Nichols, the CRC voted 4-0 to present this case to the Board and recommend that the Board take no further action against the corrections officer who was the subject of this complaint.

Case No. 2024-046 On a motion by Stark seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board take no further action against the corrections officer who was the subject of this complaint.

Case No. 2024-073 On a motion by Stark seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board grant a waiver to this BLETP applicant for engaging in conduct constituting the Class D crime of unlawful possession of scheduled drugs.

Case No. 2024-063 On a motion by Stark seconded by Bushey, the CRC voted 4-0 to present this case to the Board and recommend that the Board take no further action against the corrections officer who was the subject of this complaint.
