On behalf of your law enforcement liaisons, we want to welcome you back to summer. With the past 14 or 15 weekends in a row containing some amount of rainfall, I'm guessing many of you are ready for summer and all that goes with it.

From the Bureau of Highway Safety, we continue to see the number of fatalities on our roadways remain consistent with last year's numbers at this same time, considering the rainy weekend weather pattern we've dealt with. With longer days, favorable weather, and increased traffic from both motor vehicles and motorcycles ahead management, and young drivers. of us, we in law enforcement will need to work hard to seek the required level of voluntary compliance from our motorists to support ongoing safety on our roadways.

When our men and women in uniform are con-

ducting traffic enforcement work, it might be helpful to share with motorists why patrol function, specifically traffic enforcement, is so vital to safety. The gold standard for this data is NHTSA's "Countermeasures That Work," a robust guide for State Highway Safety Offices and other professionals to select effective, evidencebased countermeasures for various traffic safety problem areas. The guide covers 10 key areas: alcohol- and drug-impaired driving, bicycle safety, distracted driving, drowsy driving, motorcycle safety, older drivers, pedestrian safety, seat belts and child restraints, speeding and speed

Regardless of the specific type of targeted traffic enforcement an Agency conducts, it's high visibility enforcement (HVE) that leads to positive

driving behavior during and after a campaign. These campaigns continue to be areas the Bureau of Highway Safety can support through NHTSA grant funding by utilizing crash data in your communities.

Over the past few years, many agencies across Maine have replaced BHS-funded details with other federal funding streams that still allowed for traffic enforcement work. If your Agency is interested in seeking BHS grant funds for traffic safety work, please reach out to Jim or me to help with that process.

In closing, we'd like to highlight the ongoing great work that the Maine Chiefs of Police District Two (Cumberland County) under the leadership of Chief John Kilbride, Falmouth Police Department. These law enforcement agencies have joined together for the last several weekends and will continue to do so for the remainder of the summer to conduct RIDE (Regional Impaired Driving Enforcement) details in each Cumberland County

town.

Although RIDE details have historically been funded by BHS, MCOPA D2 has self-funded this rotating weekend event to combat the growing prevalence of operating under the influence cases across Cumberland County. BHS is supporting this work by providing the roadside testing vehicle for Officers to process OUI cases in the field to increase efficiency in the detection and processing of OUIs.

RIDE details were much more prevalent across



#### **Updates From**

Impaired Driving Enforcement Training Unit



Applications are open for a select number of seats in Maine's next Drug Recognition Expert school, scheduled for February, 2026.

When officers make an arrest for operating under the influence, and a breath test indicates it's not just alcohol causing impairment, Maine's DREs are called in to evaluate the person. DREs can identify a category of drug(s) that the person is impaired by, and also identify many medical conditions that some times look like impairment.

This course isn't easy; in fact, it's probably the most academically challenging course offered at MCJA. The application process isn't easy, either. Students will need to submit a supplemental application, answering information about their experience and training in OUI enforcement, obtain letters of reference, and submit their two most recent OUI arrest reports. From there, the DRE advisory committee will select a number of applicants to interview, and select students to attend the classroom portion of training. That list of selected students must then be approved by the Commissioner of Public Safety.

This article is intended to introduce you to the resources tab of the Maine TSRP page. While your Maine TSRPs are ready and available to help you with any impaired driving related question, we also try to post information and resources that may be of use to you. Where we do that is on TSRP page of the Maine Bureau of Highway Safety's website. The current items found under the resources tab on that page include the following:

The Maine OUI Guide: This should be a staple resource for anyone involved in OUI investigation or prosecution. The Maine OUI Guide was created in 2020 by TSRP Scot Mattox and Lori Renzullo (then legal intern, later attorney and ADA, and formerly police officer and MDEA agent), with edits by retired Judge David Kennedy. It has been continually edited and updated, and it strives to include OUI relevant case law and information using a step-by-step or topic-by-topic approach.

our State pre-COVID-19. This is a mission BHS would like to support across the State as staffing levels grow. Please reach out to either Jim or me to continue the discussion about reinstating this program.

#### **TSRP Talk continued:**

Cannabis Violations Visual Chart: This resource was created by TSRP Mattox to assist Maine law enforcement officers in determining whether they could stop a vehicle or person for their use or possession of cannabis. Each column reflects a category of laws and age group while each row reflects an action related to cannabis. It should be noted that the "Operating a MV Under the Influence" column is intended to ask, "May the person operate a motor vehicle under the influence of cannabis?" For more information on this chart, please read the related article, found under the relevant articles tab, titled "Cannabis Violations and Highway Safety."

Suggested Cannabis Impaired Driving Investigation Techniques for SFST Trained Officers: This useful document relates to the "Cannabis Studies: What Traffic Safety Professionals Need to Know" class offered by Maine's TSRPs. In the document, TSRP Mattox combines roadside investigations with lessons from scientific studies to guide officers in detecting cannabis impairment.

**Vehicular Manslaughter:** This document is a checklist of sorts used by prosecutors when assisting with fatal crash investigations; it is intended to help ensure a thorough investigation. It is invaluable and was developed by ADA Pat Mador. Everyone involved in traffic safety should familiarize themselves with this document, know where to locate it, and use it in all fatal crash investigations.

**Recreation Marijuana – Impacts on Public Health & Safety:** This is the latest resource available on the page and was originally developed by Pennsylvania's TSRP, Nathan Boob (the PA TSRP). In it, the PA TSRP addresses four impacts of cannabis on public health and safety and, by category, discuses related publications. For example, under the impact "Marijuana causes physical harm to recreational users, children, pregnant women, and people subjected to secondhand exposure," the PA TSRP discusses the impacts of cannabis on working memory while citing a related study.

In addition to these resources and as earlier referred to, articles on various topics can be found under the "Relevant Articles and Essays" tab. Such articles include an introduction and link to a "Cops in Court" video, a discussion of blood evidence in OUI, a discussion of place of last drink data, and more.

We hope that all such resources and article will be useful to you – our traffic safety partners. If you ever have a need or idea for more information or resources, please reach out to us and ask. We will do our best to find or create something to suit your needs.

#### A Solution to Help Young Children Shine



Help Me Grow is a central access point designed to connect families to information and services about child development and community resources.

In partnership with 211 Maine caregivers and providers can contact Help Me Grow for additional support. Help Me Grow will listen, link families to services, and provide follow-up to both caregivers and referral sources.

#### How It Works:

#### Eligibility

We are available at no cost to all Maine children, birth to eight, and their families/caregivers. Parents can also call for assistance during pregnancy.

#### Centralized Access Point

We assist caregivers and child health providers in connecting children to the grid of existing community and State resources that can help them thrive, through a "warm hand-off" from families to resources.

#### Resources

We help support a network of connected service providers, that can effectively serve families in Maine who have a variety of needs.

#### **Developmental Screening**

We promote working with families to recognize developmental milestones and utilize the Ages & Stages Questionnaires® (ASQ) to assess development. If concerns are identified in the screening process, we work with families to connect to early intervention professionals for further assessment.

#### Consider Referring A Family When:

- You are unsure what services a family might be eligible for, but know they need support.
- A family needs additional support navigating next steps in accessing resources (CDS, WIC, etc.).
- A screening needs to be completed, or family needs support completing an online ASQ®.
