# 3. OPERATIONS REPORT – Deputy Director Matthew Motti

Operations – In June there were (5) shipments of machines and/or associated equipment shipped to or from licensed facilities. In July there were (18).

There were (67) work orders completed in June and (119) in July which ranged from new game installs, removals, changing themes, options and communications issues.

There were (52) entries in the inspector pass on log in June and (57) in July to share information not only from within the facility but also between the facilities.

In June there were (5) formal complaints and in July there were (5) with status updates reported in the complaint dashboard;

- (15) Consent agreements are being completed by the Assistant Attorney Generals,
- (4) Letters of Guidance issued,
- (6) Dismissed for insufficient gravity to warrant a formal violation, and
- (4) are being responded to by the facilities.

There were (2) patron complaints.

### 4. FINANCIAL REPORT – June 2025 and July 2025 – Alex Joutov

Tax Revenue collected from both Casinos to the State of Maine decreased by 3.1% (or, by \$182,895) in June 2025 and increased by 1.66 (or, by \$101,778) in July 2025 compared to the same months in 2024.

Total Tax Revenue collected from both casinos so far during 2025 was \$40,147664, which is an increase of 1.43% (or \$565,608) compared to the prior year.

Specifically, by Casino —

Oxford casino reported a total net win of 7.23% from Slot machines and 21.80% from Table Games for June 2025. They reported a total net win of 7.58% from Slot machines and 26.65% from Table Games for July 2025.

Hollywood casino reported a total net win of 8.70% from Slot machines and 27.11% from Table Games for June 2025. They reported a total net win from Slot machines of 8.47% and 23.64% from Table Games for July 2025.

In the area of Advance Deposit Wagering –

Revenue increased by 106% (or \$18,085) in June 2025 and increased by 48% (or \$9,356) in July 2025 compared to the same time last year.

Total Tax Revenue collected from out of state and in-state races so far this year was \$181,461, which is an increase of 41% (or \$52,694) from the same time last year.

### 5. EXECUTIVE DIRECTOR REPORT

Director Champion began his report by introducing the new Administrative Assistant Ryleigh Brown. He reported that after 30 years of service Det. Donnie Armstrong will retire, and the position will not be replaced.

The director reported that the rulemaking update includes the Certified Laboratory rulemaking, currently under legal review and due October 17<sup>th</sup>. With approval today, chapter 13's legal review will be due 120 days from the date it is forwarded to the Attorney Generals office.

Pursuant to 8 M.R.S. § 1003 (Powers and duties of board), and 8 M.R.S. § 1005 (Powers and duties of department) the Director will initiate a competitive bidding process for the completion of background checks related to business organizations and their key executives, directors, officers, partners, shareholders, creditors, owners and associates for licensure which may include a mini bid of pre-qualified vendors. Currently there are two pre-qualified vendors; GLI Gaming Laboratory International and GIS Gaming Integrity Services, GIS is currently under contract to review business entity backgrounds for fantasy and sports wagering.

In an effort to allocate more training to unit staff as well as casino inspectors, Director Champion has arranged for GLI to provide training here in Maine rather than send staff to Las Vegas for the annual training course.

### a.) Interblock USA LLC. - Table Games Distributor - Renewal
