1. CALL TO ORDER

3. OPERATIONS REPORT – Deputy Director Matthew Motti

In April 2026 there were 7 shipments of machines and/or associated equipment shipped to or from licensed facilities. In May 2026 there were 7. There were 99 work orders completed in April 2026 and 74 in May 2026 which ranged from new game installs, removals, changing of themes, options and communication issues.

There were **45** entries in the inspector pass down log in April 2026, and **55** in May of 2026, to share information not only from within the facility but also between the facilities.

In April 2026 there were three formal complaints and in May of 2026 there was **1**. The status updates reported on the complaint dashboard include **10** consent agreements are being completed by the assistant attorneys generals of which some are combined with others to total **13**; **9** of which are under review by the investigation committee and **3** are awaiting response by the facilities.

There were no patron complaints in April or May 2026.

Self-exclusions. In February and March there were **34**. For April and May There were **30**.

In March 2026, there was a total of **499** individuals on the self-exclusion list and 529 individuals in May 2026.

Board Member Noel March asked Deputy Director Motti who currently serves on the investigations committee. Deputy Director Motti responded that the group includes Director Champion, and Assistant Attorney Generals Phil Mantis and Reid Hayton-Hull.

Assistant Attorney General Reid Hayton-Hull explained that a group consisting of Deputy Director Motti, Director Champion, AAG Phil Mantis herself, and the Commissioner reviews and discusses cases, which Board Member Noel March acknowledged and thanked everyone for clarifying.

Board Member D'Arcy Main-Boyington asked about the significant increase in problem gambling intake reports, noting that March, April, and May showed much higher numbers than in earlier months and asking whether any changes had contributed to the trend. Board Chair Steven Silver explained that March is typically a busy gambling month, but the recent increase has largely been driven by online gambling, including iGaming and prediction markets, particularly on unregulated platforms with a minimum gambling age of 18 compared to Maine's regulated age of 21. He stated that the Board is closely monitoring these trends and may invite Lori Manson, or a representative from ADEPT, to provide additional information at a future meeting. Board Member Main-Boyington emphasized the importance of continuing to monitor the data and exploring ways the Board might address the issue

4. FINANCIAL REPORT – April and May 2026 – Amanda Spencer

Tax Revenue collected from both Casinos to the State of Maine increased by 0.8% (or, by \$45,273) in April 2026 and increased by 0.7 % (or, by \$42,876) in May 2026 compared to the same months in 2025.

Total Tax Revenue collected from both casinos so far during 2026 was \$28,787,288, which is an increase of 2% (or \$587,766) compared to the prior year.

Specifically, by Casino —

Oxford casino reported a total net win from Slot machines of 7.4% and a total win from Table Games of 27.2% for April 2026; and a total net win from Slot machines of 7.3% and a total win from Table Games of 19.2% for May 2026.

Hollywood casino reported a total net win from Slot machines of 8.5% and a total win from Table Games of 22.3% for April 2026; and a total net win from Slot machines of 8.5% and a total win from Table Games of 22.3% for May 2026.

ADW Report: Wagering revenue increased by 47% (or, by \$8,620) In April and increased by 15.7% (or, by \$9,25) in May 2026 compared to the prior year. Total Tax revenue collected from out of state and in state races currently \$161,895 which is an increase of 38% (or \$44,619) compared to the prior year.

5. EXECUTIVE DIRECTOR REPORT

Director Champion is attending the I-Gaming IQ training held in Lakewood NJ by GLI to improve your I-Gaming IQ June 16 and return June 17th, 2026 at their NJ headquarters in preparation for I-Gaming in Maine. Director Champion along with four other staff members attended the North American Gaming Regulators Association conference in Sarasota, Florida last week which was very productive and the ability to establish relationships with other states which was as always was the highlight.
