BRIEF SUMMARY: These rules are to comply with changes in state law under 8 M.R.S.A., Chapter 39.

Establishes rules for internet gaming to include eligibility for license, house rules, wagering systems and accounts, cybersecurity, geolocation, responsible gaming, advertising, promotions, contracts and complaints.
