C. <u>Law Enforcement Training Committee:</u> Deputy Chief David Bushey

Deputy Chief Bushey told the Board members that the Zoom meeting with the Law Enforcement Advisory Committee, which is chaired by Chief MacKenzie went well, and the topics were chosen for this year. He said that Chief MacKenzie is hoping that the next meeting of his committee would be in September and that they were going to try to meet every year in September. This would let them get the mandatory topics to the Law Enforcement Training Committee who would, in turn, get them to Academy staff so they could be presented to the Board as early as the January meeting. After being approved by the Board, those topics could be sent out to Police1 and Dirigo Safety so they could get them online earlier in the year.

D. <u>Corrections Training Committee:</u> - Commissioner Randall Liberty

Commissioner Liberty told the Board that the 85th BCTP graduated last week with 42 new Correction Officers. The new Probation and Parol Training Program's curriculum will hopefully be finished and ready for approval by the July 11th Board meeting.

He said that John Lappin, a DOC employee, who has been embedded at the academy for the last two years, will be returning to Probation and Parole and CCTW Richard Guckin will be taking his place.

VIII. Item Eight on the Agenda: Report from the Chair - Chief Charles Rumsey IV

In April, I submitted testimony in opposition to LD 723, An Act Requiring the Maine Criminal Justice Academy to Develop a Nonresidential Basic Law Enforcement Training Program. Director Peck will spend some time discussing his efforts with the current legislature and the status of this bill.

I also had conversations with several individuals regarding a bill that sought to create a special classification of law enforcement officer called a School Safety Officer. Following those conversations, the sponsor of the bill pulled it from consideration.

In the past several months, Director Peck, Assistant Director Ryder and I did some work regarding annual mandatory training for law enforcement officers. Following that work, I have some recommended changes to our bylaws that I want to propose. Because our bylaws require at least 14 days' notice and

provision of the proposed changes to the bylaws prior to a vote, we won't take the matter up today but will address it at our next meeting.

We have a new Board member – Bill Post, the Assistant City Manager of Augusta, who will be filling the municipal official seat. Bill comes to us with a very lengthy career in municipal management and a great reputation. He is unable to join us today but plans to be with us in July.

IX. Item Nine on the Agenda: Report from the Director – Director Jack Peck

Director Peck spoke on the following topics.

On Monday, May 5th the Basic Law Enforcement Training Program (BLETP) class began week fifteen of their eighteen-week program.

This is the largest class to ever start a BLETP. On January 21st, eighty-two Cadets started the program. Seventy-six remain with five leaving voluntarily and one dismissed for an integrity violation.

"Crimes in Progress" and the MARC finals started yesterday May 8th. Volunteers from all across the state assist in training the Cadets with these scenario-based exercises.

This is another diverse class with several multi-language learners, 22 military veterans, 33 with advanced education, 14 females and for the first time in years a tuition student from Thomas College.

The Cadets will attend the Law Enforcement Memorial Ceremony on May 13th. The Cadets will be very busy in their last weeks of the program with finals exams, the Mechanics of Restraint Arrest and Control (MARC) final exercise and completing the physical testing graduation standard.

"Family Day" will be held on May 15th. We have almost ninety signed up for the event. This is an opportunity for family members and loved ones of the current BLETP class to ask questions and learn about their training experience and future expectations. We also have guests who provide context and personal experiences of living with a law enforcement officer.

Graduation will be held on Friday, May 23rd and the commencement speaker will be retired Chief of Investigations for the Maine Attorney General's Office, Brian MacMaster.

The 85th Basic Correction Training Program graduated on May 2nd. Forty-one correctional professionals earned their certification.

The commencement speaker was Maine House of Representatives Chad Perkins, Piscataquis County Sheriff Bob Young and Maine Department of Corrections representative Director of Operations Gary LaPlante.

Sixteen new drug recognition experts were trained and passed certification in April. This was a culmination of a rigorous process that started several months ago with applications and interviews. The final training and exam concluded with actual field testing of individuals in Jacksonville, FL.

This training is in collaboration with the Maine Bureau of Highway Safety and NHTSA.

In-service training in the immediate future includes a LEPS II class that starts on Monday, May 12th at CMCC and an Advanced Roadside Impaired Driving Enforcement (ARIDE) that was that was held last week in Presque Isle and another class in Holden (that is full) starting on May 15th.

We have a Methods of Instruction (MOI) class in session now and they will graduate next Friday, May 16th.

The 2024 Annual Report to the Legislature was completed and delivered on April 1st. The report is available on the MCJA website.

The first special session of the 132nd Maine Legislature has been very active, and I have had to provide summaries, testimony and fiscal notes on behalf of the Maine DPS for several bills.

One bill we spoke in favor of was introduced at the request of Board Chair Rumsey, which was An Act to require law enforcement agencies to adopt written policies regarding compliance with certain constitutional obligations related to disclosure of evidence.

Another LD we provided testimony and support for was An Act to develop minimum policy standards for anti-sex-trafficking and commercial sexual exploitation.

Other bills we collaborated with either bill sponsors or subject matter experts was An Act to Require First Responder Training for Mental Health Crisis and Critical Incident Stress Recognition, An Act To Allow Consumption Of Adult Use Cannabis In Locally Approved Hospitality Lounges and An Act to Hire School Security Officers to Protect Students and Make Schools Safer an Act to require first responder training for mental health crisis and critical incident stress recognition and an Act to waive Basic Law enforcement training requirements for full-time law enforcement officers who have successfully completed equivalent courses in other jurisdictions.

The MCJA Complaint Review Committee met on April 30th and evaluated fifteen cases of admitted or alleged misconduct by current or potential future certificate holders.

CRC cases continue to rise, and we have received thirty-six reports of misconduct or requests for waivers due to prior misconduct.

The exterior building project to remove, improve and replace existing masonry is expected to be completed this month. This work started in January of 2023.

The process to begin renovations to the interior, HVAC upgrades and improve life safety issues in C building will begin today on May 9th with the opening of the Requests for Proposal's. Work is expected to begin in June.

Due to the renovation project, we are working in collaboration with the Office of the State Fire Marshal to determine if the basement in the current billet could be used for temporary housing if needed for the 48th BLETP starting in August.

The Director and Assistant Director attended the Maine Sheriff's Association annual training and awards banquet held in Portland on April 3rd and 4th.

The Director and Assistant Director will attend the Maine Chief's of Police Association's annual training and awards banquet which will be held in Portland on May 15th and 16th.

Staff update:

OAII Jamalyn "Jamie" Brown was hired in April to replace departing OAII Cheryl Twitchell. Jamie is in her 3rd week of training as the primary staff member at the lobby window.

Building Update:

We continue to work with staff and the Bureau of General Services to identify and correct issues with the building. We continue to experience issues in A building with water intrusion during high wind/rain events in 2 rooms which are being worked on by BGS. Hot water issues in A-building have been mitigated somewhat through BGS staff work over the past several months, however, there are still additional problems that need attention. I am coordinating with cadre staff, the class, and BGS on identifying the further needed work.

Grants:

COPS grant for FY24 SAFER OUTCOMES: Enhancing De-Escalation and Crisis Response Training for Law Enforcement is still in beginning phases of implementation.

The International Association of Directors of Law Enforcement Standards and Training were conditionally awarded the contract to conduct a Job Task Analysis and Curriculum Development for a BLETP update and integration of De-Escalation and Crisis Response Training pursuant to the RFP process. We are in the process of finalizing the contract and work. We are in the final stages of instituting a project manager to administer the project which should be completed in the next two weeks.

We sent a notice through Maine Chiefs of Police Association and Maine Sheriffs Association to attempt to recruit 20 SMEs to work on the project and serve as the primary cadre of instructors for the curriculum. These SMEs will attend the We hosted Force Science Institute's Realistic De-escalation Instructor Course April 16-17 hosted at the Academy and were able to train 24 SMEs as instructors to assist with the development and delivery of the curriculum.
