The Board of Trustees of the Maine Criminal Justice Academy are pleased to present its 2022 annual report to the Joint Standing Committee on Criminal Justice and Public Safety. As you will see, this report is both informative and responsive to the statutory requirement for its production, and the Board is confident that the report will provide the Legislature with the information necessary to ensure that appropriate and timely training is accomplished.

The Board of Trustees, which is comprised of citizens, law enforcement, corrections, and legal representatives, remains committed to the citizens of Maine as the oversight board for the Maine Criminal Justice Academy as it relates directly to; admission standards, training curriculum, policy standards, and the certification and de-certification standards for the more than 5,000 law enforcement and corrections certificate holders.

The Board of Trustees have been responsive to the needs of both the citizens of Maine and the public servants in the law enforcement and corrections community by conducting regularly scheduled public meetings throughout the year.

The Board continues to review and evaluate the statutorily required minimum policy standards for Maine law enforcement agencies and is in the process of developing several additional standards of officer conduct, through the rule making process. These standards of conduct will ultimately enhance the Board's authority and oversight, relating to matters of misconduct by the officers certified through this institution.

As a proactive approach to maintaining current and national best standards for training, the Maine Criminal Justice Academy is currently engaged in the development of a strategic

development plan, that is being conducted by nationally recognized consultants. This comprehensive review is expected to be completed later this year and will evaluate areas to include our admission standards, program curriculums, fiscal resources, staffing, facilities, and our relationships with those we serve.

I would like to recognize our soon departing Academy Director Richard Desjardins, who is leaving the Academy this spring to undertake a new assignment as the Director of the Maine Drug Enforcement Agency. Director Desjardins began his leadership role at the Academy in February of 2020, days before the worldwide pandemic reached our shores.

Director Desjardins ability to adapt and overcome was impressive as he led his staff through one of the most challenging times in this institution's history. Director Desjardins was the right leader at the right time. In transition, Assistant Director Peck and his staff have the full faith and confidence of the Board to successfully carry out the mission of the Maine Criminal Justice Academy as we begin the search for a new director.

The Board of Trustees and the staff of the Maine Criminal Justice Academy remain fully committed to promoting the highest standards of professionalism and training to Maine's law enforcement and correctional officers throughout the State. We further stand ready to appear before the Committee to elaborate on any issue associated with this report or with the Academy and its mission.

Senator Beebe-Center, Representative Salisbury and Committee Members:

I would like to thank you for your work during this past legislative session and hope this report helps highlight some of the accomplishments and actions by our Academy and the Board of Trustees. Maine's law enforcement and corrections professionals have faced many challenges over this past year but despite the recent challenges, I continue to see improvement and I look forward to working with the Committee Members in the coming legislative sessions.

Our Academy is the central training facility for state, county, municipal law enforcement and corrections officers. The campus is located at the former Oak Grove-Coburn School in Vassalboro, Maine. From 1972 until December 28, 2000, the Academy was located at 93 Silver Street in Waterville, at the former Thomas College facility. The Academy has twelve (12) classrooms, four (4) conference rooms, a full cafeteria and can house 130 students. The building has a tactical training center, an indoor running track, outside obstacle course, and formal parade grounds.

The mission of the Maine Criminal Justice Academy is to provide the highest level of training with our given resources, to law enforcement and correctional officers in the State. By statute, the Academy is required to provide a basic training program for all full-time law enforcement officers, all part-time law enforcement officers, all county and state correctional officers, all Judicial Marshal's and all Capitol Police officers. The Academy also coordinates the 8 Regional Training Districts across the state, many of which provides academy certified training and other training to officers in remote areas.

In addition to the full-time staff, the Academy relies heavily on volunteer instructors from state, county and municipal law enforcement agencies, county and state corrections agencies and others in the criminal justice fields. During 2022, the Academy had instructor hours of 16,406.5 (17,135 in 2021) donated from 123 different agencies for Regional, In-service, Law Enforcement Pre-service, the Basic Corrections Training and the Basic Law Enforcement Training Program.

During 2004, the Academy completed a Job and Task Analysis (JTA) on what law enforcement officers do in the field. From this information, we have set our current course and curriculum goals and objectives for the BLETP. Working with our Board, the staff and our subject matter experts continue to update lesson plans as laws and techniques evolve and we develop new curriculum using adult learning principles and integrating a "community policing philosophy" and "ethics" into as many courses as possible. The Academy's staff provide instructor development classes throughout the year to train new volunteer instructors in order to sustain our ability to provide this vital training.

In 2006, we completed work with the National Institute of Corrections (NIC) to completely redo the Basic Corrections Training Program (BCTP). We started by NIC and MCJA completing a Job & Task Analysis and then NIC provided some technical assistance to the Academy on a revision of the BCTP. The Board and the Academy staff worked to revamp the BCTP to bring it up to date with new standards, including writing all new lesson plans. The new BCTP started on July 1, 2015 with a 200-hour program. The new entrance requirements added to the existing background check were passing the written Alert Test and a medical physical from a healthcare professional. In 2018, we increased the program to 208 hours to accommodate an 8-hour class on Mental Health.

We are currently engaged with Slalom, a management consulting company. Slalom will be evaluating our training model, staffing, future capacity, budget, curriculum, building and technology needs and the services provided by the academy. They will be developing a strategic plan and an overall vision for the academy for the next five years. We are expecting the final version and vision to be delivered in the early summer of 2023.

The Academy produces the lesson plans with the help of content experts for mandatory in-service training. These lesson plans are converted into electronic format for officers to use by vendors who offer these classes remotely. The 2022 mandatory training topics for law enforcement officers that were offered on-line were, New Law/Case Law Updates, Law Enforcement Response to Mental Health Calls, Wellness and Resiliency for Law Enforcement and 20 hours of elective training between 1/1/2022 through 12/31/2022. The 2022 mandatory training topics for corrections officers were also on-line by Police One and Dirigo Safety and they were: New Law Updates, Officer Development, Leadership in Corrections and one (1) elective topic of choice.

The Board of Trustees of the Academy awards certificates to Law Enforcement and Corrections Officers, Executives, Instructors, Canine Teams, Drug Recognition Experts, Traffic Reconstruction Experts, and others. The Board continues to update the mandatory standards for the 14 mandated policies for law enforcement agencies in the State. The Board also certifies all new courses and grants waivers and extensions to law enforcement and corrections officers in emergency or extenuating circumstances, as well as decertifies law enforcement and corrections officers

In 2017, we started the process to correctly identify the gender of all officers. By the end of 2022, it was determined that there were 296 full-time female law enforcement officers or 10.54% and 41 part-time female law enforcement officers or 7.97% employed. By the end of 2022, it was also determined that there were 244 female corrections officers or 19.35% (15.30% in 2021) employed. Nationally, 12.5% are full-time female law enforcement officers (2017 FBI Crime in the US, Table 74).

During calendar year 2022, the Academy Board of Trustee actions were as follows:

- Waivers (20 in 2021) of the 720-hour Basic Law Enforcement Training Program were granted.
- Extensions (118 in 2021) to attend the Basic Law Enforcement Training Program were granted for emergency or extenuating circumstances. * Increase due to pandemic and suspensions of BLETP

- 5 Extensions (8 in 2021) to attend the Basic Corrections Training Program were granted for emergency or extenuating circumstances.
- Waivers (0 in 2021) of the Law Enforcement Preservice Course were granted.
- Extensions (3 in 2021) to attend the Part–time Law Enforcement Officers working more than 1040 hours in a calendar year were granted for emergency or extenuating circumstances.
- **0** Extension (0 in 2021) of the Judicial Marshal Program was granted.
- Judicial Marshal Certifications (13 in 2021) were granted.
- 16 Intermediate Training Certifications (12 in 2021) were granted.
- Advanced Law Enforcement/Corrections Certifications (8 in 2021) were granted.
- **3** Executive Certifications (4 in 2021) were granted.
- 39 Instructor Certifications (51 in 2021) were granted.
- Firearms Instructor Certifications (25 in 2021) were granted.
- 2 Crash Re-constructionist Certifications (0 in 2021) were granted.
- Canine Handler Team (Patrol and Detector) Certifications (4 in 2021) were granted.
- 2 Canine Team and Assistant Canine Team Trainer Certifications (1 in 2021) were granted.
- Drug Recognition Expert Certifications (0 in 2021) were granted.
- 1 Crisis Negotiator Certifications (3 in 2021) were granted.
- Breath Testing Device Instructor Certifications (17 in 2021) were granted.
- **0** Physical Fitness Testing Protocol Certifications (26 in 2021) were granted.
- **6** Chaplain Certifications (7 in 2021) were granted.
- 6 New Courses (7 in 2021) were approved.
- **3** Tactical Team Certifications (2 in 2021) were granted.
- 4 Consent Agreements and/or Suspensions of Certifications (10 in 2021) were issued.
- Law Enforcement/Corrections Officers (7 in 2021) voluntarily surrendered their certificates of eligibility or were revoked for criminal conduct or were revoked for failure to meet Board training.
- **8** Waivers (8 in 2021) of convicted persons to attend Academy programs were granted.
- **0** Reinstatement of Law Enforcement/Corrections Officer Certifications (0 in 2021) were granted.

Again, I want to thank the members of the Joint Standing Committee on Criminal Justice and Public Safety for all the hard work you do and for your support of the Maine Criminal Justice Academy. I would like to extend to your committee members on behalf of my staff, the Board of Trustees and myself, any assistance, advice or guidance we can give you or to help you in your committee work, as it relates to the Maine Criminal Justice Academy.

ABOUT THE ACADEMY

The origin of organized law enforcement training in Maine dates to the late 1960's when the Federal Law Enforcement Assistance Agency made funds available through the Maine Criminal Justice Planning and Assistance Agency for improving the operation of the criminal justice system. Using this as seed money, the Maine Municipal Association initiated a two-week law enforcement training program offered in the Portland, Augusta, and Bangor regions. A Board of Directors, consisting of law enforcement officials, was charged with overseeing the program and encouraging law enforcement agencies to support the training.

The early 1970's saw passage of the Mandatory Training Act for law enforcement and in 1972 the former Thomas College in Waterville was purchased to provide permanent facilities for the Maine Criminal Justice Academy. Since that time, the scope of activities at the Academy has steadily increased. In 1990, new legislation required that all law enforcement officers, state, county and municipal, who have the power of arrest and the authority to carry a firearm, come under the purview of the Academy's Board of Trustees. This has greatly increased the responsibilities and tasks of the Academy.


The Maine Criminal Justice Academy is responsible for the development and implementation of comprehensive training programs both at the Academy and through outreach programs across the state.



With this responsibility the Academy is providing:

- 1. A residential training facility to accommodate the needs of Maine's criminal justice professionals.
- 2. A training delivery system to reach all parts of the State.
- 3. A centralized administrative structure which promotes coordination and communication; and
- 4. A repository of support services that promotes research, management, and training activities of all types.

The citizens of Maine have a reasonable expectation that extensive training is provided to criminal justice personnel, particularly those responsible for dealing with emergency situations, which could involve life and death decisions. Court decisions have held that it is the responsibility of criminal justice agencies to ensure that their personnel receive training, which supports the quality performance these citizens expect and deserve. At present, the Maine Criminal Justice Academy is the primary vehicle for Maine criminal justice agencies to meet these obligations.



SUMMARY OF TRAINING ACTIVITIES FOR 2020 LAW ENFORCEMENT TRAINING

Basic Police Training

The basic training for law enforcement officers for the calendar year 2022 consists of the following:

- 2 Basic Law Enforcement Training Programs (720 hours) for 121 students.
- 6 Pre-Service Law Enforcement Courses Phase 1 (40 hours),
 Phase II (80 hours) and Phase III (80 hours) for 146 students.



In-Service Training

During calendar year 2022 the Academy provided the following basic certification training:

- 121 students graduated from the **Basic Law Enforcement Training Programs (BLETP),** 720 hours in length (2 programs).
- 146 students completed the **Law Enforcement Pre-Service Training Program (LEPS)**, 200 hours in length (6 programs).
- 184 students graduated from the **Basic Corrections Training Program (BCTP)**, 208 hours in length (8 programs).

The 2022 mandatory in-service training requirements for all law enforcement officers were:

- Two (2) hours of MCJA Firearms Qualification
- Two (2) hours of New Law/Case Law Updates
- Three (3) hours of Law Enforcement Response to Mental Health Calls
- Three (3) hours of Wellness and Resiliency for Law Enforcement
- Twenty (20) hours of elective training approved by the agency.

In-service Training

The Academy conducted more than 21, 288 hours of in-service and mandated training programs to more than 4329 officers throughout the state. This training was conducted using a combination of in-person, virtual or web-based training.

Corrections Training

The 2022 mandatory in-service training requirements for correctional officers were:

- One (1) unit of New Law Updates (Material provided by the AG's Office)
- One (1) unit of Officer Development
- One (1) unit Leadership in corrections
- One (1) unit of approved elective training set by the facility, which cannot be OSHA, Department of Labor Requirements or Detention and Corrections Standards for County Jail Requirements

SIGNIFICANT EVENTS

- **1976** Municipal School increases from a ten-week program to twelve weeks. Regional law enforcement in-service training implemented.
- 1977 Dispatcher training curriculum developed.
- 1978 Basic Corrections Training Course developed. A system of reporting by corrections agencies is added to law enforcement reporting. Instructor Certification Program implemented. The Methods of Instruction Course is developed.
- 1979 Regional training certification by the Board of Trustees initiated. Supervision, Mid-Management, and Executive Development courses implemented. Arson investigation, team concept, developed. Reserve Officer Training curriculum and standards developed as directed by the Legislature.
- **1980** Mandatory in-service training for corrections officers takes effect. Advanced Arson Investigation curriculum developed. Domestic Violence Course developed. Law Enforcement Task Analysis initiated.
- 1981- Radar Operator's Course developed. Highway Safety film collection catalogued, maintained, and circulated. Specialized Instructor Certification program initiated. Intermediate and Advanced Officer Certification implemented. Firearms Instructor Course developed. Intoxilyzer Operator Certification initiated.
- **1982** Final report on the Law Enforcement Task Analysis is completed. Municipal/County Basic Police School curriculum revised. Emergency Vehicle Operator's Course developed.
- **1983** Training for part-time and reserve police officers is mandated by the Legislature. A statewide survey to identify all part-time police officers is completed. Verification and suspension procedures for the certification of police officers were initiated.

- 1984 The Honeywell computer system is installed. Basic Warden School is established at the Academy. Court Security Course developed. ALERT Test required as entrance standard for police officers. Canine Handlers Course developed. Certificates of Eligibility required of all police officers. A Task Analysis for Corrections Officers is initiated.
- **1985** Academy responsible for administration of Justice Assistance Act funds for Maine. Background investigation manual.
- **1986** Technical Assistance Program for small law enforcement agencies is initiated. Municipal Ordinance Prosecutor's Course developed.
- **1987** Report on the Academy published by the Academy Review Committee. Basic Training for public safety dispatchers initiated. Entry level Corrections Officers Task Analysis published.
- 1988 Semi-Automatic Weapons training initiated. Academy auditorium renovated. Recommended Physical Fitness Standards published. Terminal Operators Certification. All-Points Bulletin established. Advisory Committee on Corrections established. Drug Abuse Resistance Education (D.A.R.E.) instructor program.
- 1989 Law Enforcement Officers Manual standardized. New Basic Corrections Training Curriculum established. New Standardized Field Sobriety Test developed. Oak-Grove Coburn purchased. Statewide State Law Enforcement Task Analyses completed.
- 1990 Pre-Service Training Curriculum established. Statewide Regional In-Service Training Plan adopted. State Law Enforcement Training Curriculum adopted. Certification Test instituted.

- **1991** Drug Recognition Technicians certified. D.A.R.E. officers trained with Maine mentors. Community Police Strategies developed. Provided technical assistance for business crime prevention projects.
- **1992** New Decertification standards. Civil Rights training for all Law Enforcement agencies. Bloodborne Pathogens training for trainers. A.G. Task Force Report on the use of force.
- **1993 -** Law Enforcement Agency Profile Survey conducted a joint effort MCJA/UMO Graduate Program. Total Quality Management training was initiated.
- 1994 Added two citizen positions to the Board, bringing the Board membership to 17 members. Extended employment probationary period to one year after graduation from the basic law enforcement course. Increased the minimum age requirement for entry into the Municipal/County Basic Police School to 21 years of age, or 20 years of age if the applicant has an associate degree or 60 hours of post-secondary education. Upgraded computer networking capabilities to include regional offices.
- **1995** The Board established minimum physical fitness and academic standards for all officers entering the Municipal/County Basic Police School. The Board also developed eight minimum policy and procedure standards that were distributed to all law enforcement agencies in order for them to submit to the Board the adopted final policies, as required by legislation. Also, effective January 1, 1996, each law enforcement agency was required to report to the Academy all excessive use of force complaints and the disposition of those complaints. A report from the Board was submitted to the Criminal Justice Committee recommending the implementation of joint training of Municipal, County and State Police. The program recommendations to the Board of Trustees for revision of the curriculum was completed for the new joint basic law enforcement training program.

- **1996** Academy received a federal grant to strengthen community policing in Maine by effectively responding to domestic violence cases.
- **1997 -** Governor Angus King submitted a \$10 million bond package to the Appropriations Committee for the renovation or construction of a new Criminal Justice Academy.
- **1998 -** The Legislature appropriated \$11,271,203 to renovate the former Oak-Grove Coburn school and construct a specialized training facility.
- 1999 The Maine Criminal Justice Academy Board of Trustees, following a recommendation from the Law Enforcement Advisory Committee established mandatory annual in-service training requirements for the year 2000. The Board of Trustees is also working to establish entrance standards for the combined Law Enforcement Basic Training Course and the entrance requirements for tuition students.
- **2000 -** The Maine Criminal Justice Academy's staff and programs moved to a new facility in Vassalboro, Maine. This was also the first year that all law enforcement officers were required to complete mandatory in-service refresher training.
- **2001 -** During this year the 1st Basic Law Enforcement Training Program involving eighteen weeks of training that combined state, county and municipal law enforcement officers was implemented at the new Maine Criminal Justice Academy's facility in Vassalboro, Maine.
- 2003 The Academy accepted the first two tuition students into the Basic Law Enforcement Training Program. The Academy also applied for and received a federal grant to conduct a Job & Task Analysis of the Basic Law Enforcement Training Program to update the curriculum.
- **2004 -** The Academy completed a Job & Task Analysis of the Basic Law Enforcement Training Program. New Goals and Objectives were identified and implemented.

2005 - The Academy offered nine courses "*on-line*" to assist agencies in complying with Board mandated training for law enforcement officers. More than 7,500 courses were completed on-line saving agencies tens of thousands of dollars in officer overtime, travel and replacement costs.

2007 – The Academy entered into a partnership with Northeast Counterdrug Training Center out of Pennsylvania to put on tuition free training in Maine for topics such as: Interview and Interrogation, Identifying Deceptive Behavior, Leadership and Mastering Performance, School Resource Officer, Advance School Resource Officer, Video Surveillance Techniques and other management type courses. This partnership should continue for many years.

2007 – The Academy closed the Southern Maine office, which was located at the Southern Maine Community College in South Portland.

2008 – The Academy had a 3rd parking lot constructed adjacent to Building A which can hold another 57 vehicles.

2009 – The Academy was allowed to hire Kate Faragher Houghton as a contract curriculum writer. The focus will be on the new Law Enforcement Preservice Program. The Academy was also able to contract with 2 agencies for full-time Cadre for the Basic Law Enforcement Training Program (BLETP). These contract Cadre positions are for a 2-year period and designed to give Cadets consistent training from BLETP class to BLETP class.

2011 – The Academy received a federal grant to replace the 20+ year old records management system. Informa, Inc. was selected, which will allow for more accurate information to be entered, online registration for training classes and for all criminal justice agencies in Maine to enter their own training records. The Academy closed the library and reopened it as a student lounge. The MCJA Student Benefit Fund purchased furniture, LCD projector, Blue Ray DVD player, surround sound system and a gaming port for the LCD projector.

2012 – The Academy received a federal grant to replace a 15+ year old Firearms Training Simulator. Meggitt Systems, Inc. was selected because this new Use of Force Training Simulator will allow for Firearms, OC Spray, Taser, Impact Tools and Flashlights to be used for training options. This advanced system will better prepare officers.

2014 – The Academy started to receive General Fund money of \$564, 839 as part of the annual budget because fines revenues were decreasing and at the same time eliminated \$564,839 from the Special Revenue Fund.

2015 – The Academy changed the Basic Corrections Training Program (BCTP) from 80 hours to 200 hours, plus added a requirement that all corrections students pass the Alert Test, prior to starting the BCTP, effective July 1, 2015.

2016 – Justice Planning Management Associates (JPMA) started offering mandatory corrections annual in-service training on-line, as they have done with mandatory law enforcement annual inservice training since 2005.

2018 – The Basic Corrections Training Program was increased to 208 hours to add a legislatively mandated class on Mental Health First Aid. It was determined for the first time that Maine employed 256 F/T and 50 P/T female law enforcement officers (8.82% and 6.42% respectively). It was also determined that Maine employed 232 female corrections officers or 15.55%.

2020 – In February of 2020 Director John Rogers retired from the Academy as the longest serving Academy Director. Also, in March of 2020 the Academy's programs were heavily impacted by the results of a global pandemic. Many programs were suspended from in-person training and remote or virtual trainings were developed to meet the training needs. In July of 2020, Assistant Director Richard Desjardins was appointed by the Board and the Commissioner of Public Safety as the new Director.

This training format causes less training being offered by the regional training councils.

Senator Beebe-Center, Representative Salisbury and Committee Members:

On July 2, 2015, Chapter 307 Public Law (L.D.25 and now 25 M.R.S. §4501) "An Act to Regulate Domestic Unmanned Aerial Vehicle Use" was enacted. This new law requires the Maine Criminal Justice Academy Board of Trustees to develop the mandatory standards for a policy, if a law enforcement agency chooses to use an Unmanned Aerial Vehicle (Drone) for law enforcement purposes. The Board adopted the Minimum Standards on March 10, 2017. This law also requires these agencies to report their use to the Commissioner of Public Safety each year. The agencies then reported their UAV use to the academy with their annual reporting requirements, as outlined in 25 M.R.S., Chapter 341. The Academy on behalf of the Commissioner reports the following information to the Legislature as part of Chapter 307 Public Law in this annual report to include: a summary description of the number of deployments for investigative purposes, the general nature of those investigations and the number of search warrants sought, and the number of search warrants obtained for the deployment of unmanned aerial vehicles.

There are 163 law enforcement agencies in the State of Maine and each chief executive officer must file an annual report to the Academy. For 2022, only 14 agencies reported that they had a UAV, and all 14 agencies had a policy in place that met the MCJA Board Minimum Standards.

Auburn Police Department

The agency had no criminal deployments and had 4 non-criminal deployments.

Brunswick Police Department

The agency had no criminal deployments and had 55 non-criminal deployments.

Cumberland County Sheriff's Office

The agency had 1 criminal deployment where a subject fled into the woods after a traffic stop. They had 5 non-criminal deployments.

Maine Forest Service

The agency reports 0 criminal deployments and 37 non-criminal deployments.

Maine State Police

The agency reports 37 deployments for criminal investigations and 62 non-criminal deployments. These cases are listed on a separate reporting sheet and available upon request.

Maine Warden Service

The agency reports 2 criminal deployments which involved a double kill moose scene and 8 search and rescues.

Old Orchard Beach Police Department

The agency reports 2 deployments for criminal purposes. One operator fled on foot after a traffic stop. The other was an attempted motor vehicle stop and the subject fled into a nearby town and abandoned the vehicle. Subject found by responding officers, not the drone.

Oxford Police Department

The agency reports 2 deployments for criminal investigations. Both were for shoplifters who fled the scene on foot. They also reported 3 non-criminal purposes.

Penobscot County Sheriff's Office

The agency reports 5 deployments for criminal purposes, 3 for subjects who fled into woods after a traffic stop and 2 for subjects who barricaded themselves in a residence

Portland Police Department

The agency reports no deployment for criminal purposes and 8 deployments for non-criminal. 5 for crash reconstruction and 3 for missing persons.

Saco Police Department

The agency reports 1 deployment for criminal purposes. Aerial coverage for a barricaded suspect. They reported 15 non-criminal deployments.

Scarborough Police Department

The agency reports 1 deployment for criminal purposes for a barricaded subject and no non-criminal deployments.

Windham Police Department

The agency reports no deployments for criminal purposes and 30 for non-criminal. 26 for crash investigations.

York Police Department

The agency reports 2 deployments for criminal purposes and 13 non-criminal deployments.

Senator Deschambault, Representative Warren and Committee Members:

On April 27, 2015, Senator Rosen, Representative Warren, and Committee Members wrote a letter directing the Maine Criminal Justice Academy Board to adopt a new standard to the mandatory policy on "Response to Mental Illness and Involuntary Commitment Policy" with the standard that states:

The policy shall require that 20% of all full-time law enforcement officers of each agency receive at least 8 hours of nationally recognized or best practice in-person training in Mental Health Identification Awareness for Law Enforcement Officers by January 1, 2018 and that the agency maintains at least 20% after that date. The training standard requirement will be sent annually to the Maine Criminal Justice Academy as part of the annual reporting requirements, as outlined in 25 M.R.S. §2805-B. This was adopted by the Board on November 17, 2017. The 8 hours of training was also incorporated as a part of the Basic Law Enforcement Training Program curriculum, so all full-time law enforcement officers have received this training since August 1, 2015.

There are 163 law enforcement agencies in Maine, several agencies are exempt because they only have part-time law enforcement officers. Each agency was sent a reporting form at the end of 2022 asking two questions. First, does your agency meet at least the 20% training requirement as stated above? Second, if not, what percentage have they met? Of the 152 law enforcement agencies, all (100%) responded, pursuant to 25 M.R.S. §2805-B and all (100%) of law enforcement agencies with at least 1 full-time law enforcement officer met this training requirement.
