MINUTES REVIEW AND APPROVAL

November 2021 Meeting Minutes approval

EXECUTIVE DIRECTOR'S REPORT

In November 2021 there were 13 shipments of machines and/or associated equipment shipped to or from licensed facilities. Since tracking began in January 2017, the Unit has reached 808 shipment approvals. On-site inspectors completed 631 observations and 31 checklists. There were 10 self-exclusions. There were 9 minor potential violations that will continue to be monitored from the Unit's activity log. There were no patron complaints and no formal complaints of potential violations placed on the dashboard.

For the month of November 2021, the Unit has identified an increase of 81.5% in total tax revenue for both facilities versus November 2020. Year to date the Unit has identified an increase of 104.3% versus last year at the same time. Oxford reported an 8.3% win for the month of November from slots and 23.8% win from table games. Oxford's payback percentage was 91.7%. Average gross win per machine of \$241.36. Hollywood reported an 9.1% average win for the month of November from slots and 24.2% win from table games. Hollywood's payback percentage was 90.9%. Average gross win per machine was \$184.41.

The GLI audit report is complete and will be forwarded to the Board prior to the January 18, 2022 meeting. Recommendations from that report were placed in the Appendix A.

Director Champion introduced the new General Manager at Oxford Casino Matthew Gallagher.

STATE POLICE REPORT

In November there were 18 new and 38 renewal investigations completed. In December there were 17 new and 49 renewal investigations completed. In both November and December there were a total of 8 TITO incidents; all have been taken care of. There were 42 calls for service in Bangor and 19 in Oxford for the local police department. Detective Armstrong assured the Board that a majority of these incidents occur in the hotel or garage rather than on the casino floor.
