#### MINUTES REVIEW AND APPROVAL

## **March 2022 Meeting Minutes approval**

#### <u>OPERATIONS REPORT – VICKI GARDNER, INSPECTOR SUPERVISOR</u>

In March 2022 there were 9 shipments of machines and/or associated equipment shipped to or from licensed facilities. On-site inspectors completed 788 observations and 36 checklists.

There were 9 self-exclusions. There were 6 minor incidents that will continue to be monitored from the activity log, 2 patron complaints; and 1 formal complaint of potential violation placed on the dashboard.

There were 28 calls for service at Hollywood Casino, of those 12 were parking lot/garage related, 4 outside, 6 hotel, and 6 Casino. Oxford had 17 calls for service, of those 4 were parking lot related, 5 hotel, 13 Casino.

#### FINANCIAL REPORT - Alex Joutov, Auditor

For the month of March 2022, the Unit has identified an increase of 30.8% in total tax revenue for both facilities versus March 2021. Year to date the Unit has identified the same increase of 42.8% versus last year at the same time.

Oxford reported a 7.9% win for the month of March from slots and 24.2% win from table games. Oxford's payback percentage was 92%. Average gross win per machine was \$256.59. Hollywood reported a 9.5% average win for the month of March from slots and 23.2% win from table games. Hollywood's payback percentage was 90.5%. Average gross win per machine was \$212.91

In the area of advance deposit wagering for the month of March 2022, we have identified a decrease of 6.7% for total in state and out of state tax revenue collected.

There has been a year-to-date decrease of 8.1% for total in state and out of state tax revenue collected versus last year at the same time.

## **EXECUTIVE DIRECTOR'S REPORT**

On March 1<sup>st</sup>, Scientific Games announced that due to the company's sale of their lottery business, it would be doing business going forward as Light and Wonder. A formal name change will take place at a later date.

Director Champion met with GLI and Light and Wonder on availability of downloading Bin files from GLI for all licensed manufacturers prior to or with software installation into the central monitoring system. These are set-up files for the central system and have nothing to do with game outcome or play of the game.

There are two contracts coming up for review -1) the Penn ADW contract, which the Director stated was initially signed for 5 years and good until May 2025, and- 2) the central site monitoring system contract with Scientific Games will have to have an amendment by July, which may require the approval of a new contract, the name will need to be changed to Light and Wonder.
