It was also reported the licensee may have exhibited a history of poor clinical decision making.

2. Informal Conference (09:45) – Case 20-150; Service Representatives Present

Summary 20-150: A licensed EMS agency terminated service twice within 45 days, without notifying the public. The second time was after a verbal warning from Maine EMS staff. The service also had three inspections in 2020 with deficiencies noted on all three inspections.
