It was determined that any statement by a licensed individual or entity that could undermine the healthcare system will be investigated and potentially considered misconduct.

MOTION: The Committee recommends resolving case 21-174 by issuing a letter of guidance to stay on file for 4 years; citing the importance of being mindful of communications - recognizing that as a representative of emergency services, one has the potential to undermine public confidence during a public health emergency. New Business

1. Proposed policy for standardized QA review/QA reviewer expectations or requirements as a part of a consent agreement or probationary condition.

Discussion ensued about the QA proposal; specifically, apprehension about requiring a third-party reviewer who is not otherwise affiliated with the EMS agency, who would be allowed access to that agency's patient care reports. Jason Oko advised that it would be possible to restrict the third-party reviewer to patient care reports for the impacted licensee only. There was a larger discussion about the potential to use pre-qualified, state-contracted, QA reviewers. There will be additional review of this proposal that will likely result in revisions and additional feedback. This will be scheduled during Old Business for the July meeting.
