2. Informal Review (Melissa) – Case 21-195

Summary 21-195: A licensed EMD service allowed an employee to perform EMD services without an active license. This case was tabled from the November 1, 2021 meeting to allow staff to seek additional information.

MOTION: The Committee recommends resolving case 21-195 by issuing a letter of guidance reminding the Center of their responsibility to use only licensed EMDs and stressing the importance of having mechanisms in place to track licensing expiration dates for their staff.
