 Informal Conference (Melissa; 09:05) - Case 20-082 (Tentative pending documentation) Summary: While actively licensed in 2020, the EMT licensee falsely represented themselves as a Paramedic to a prospective employer. The license lapsed before the case was presented to the Board and the case was set aside pending reapplication. The licensee is now seeking licensure through the reinstatement waiver process. On the reinstatement application the licensee disclosed a conviction for theft by unauthorized taking, a class E misdemeanor, in 2019 and a conviction for forgery and violating conditions of release, both class E misdemeanors, in 2020.
