 - ii. Fills role on Maine MDPB Board as pediatric rep as well
 - b. COVID
 - i. Role of EMSC Manager (Minkler) has been tasked and approved by HRSA to also take on some temporary duties assisting state office with COVID planning and

supporting office staff – have continued to perform EMSC duties as well but did result in July EMSC meeting cancellation (along with committee members being tasked with work duties)

- c. NEDARC Peds Readiness Survey
 - i. Maine EMSC worked with NEDARC to test the survey for rest of country
 - ii. EMS results (Maine and National) from 2020 are available on website on EMSC page
 - 1. Maine had 118 EMS services participate in the survey
 - iii. Sample of data results shown to the committee
- d. HRSA Annual Report
 - i. Grant report has been submitted to HRSA
 - ii. Requesting approximately \$17,000 of money to be carried forward (unused for budgeted medical director and travel due to COVID)
- e. Perinatal Systems of Care
 - i. Statewide committee looking at maternal/newborn care across the state
 - ii. Maine EMSC is on steering committee and heavily involved in multi-disciplinary approach, looking at OB resources and EMS transport
- f. Pediatric Education
 - i. Discussion of carryover money and directed skills education and PECC development across the state
 - ii. Pediatric Seizure program on MEMSed
 - iii. COVID presentation from Harvard/Boston Childrens on pediatric COVID management
 - iv. Work continues on BRUE presentation for MEMSEd
- g. NASEMSO East Region Pediatric Council
 - i. Marc is chair for the East Region for NASEMSO, working on meeting with all states
- h. NAEMSP Equipment Publication
 - i. Being reviewed by various groups for support/consensus (AAP, NASEMSO, others)

 - Maine EMSC program is submitting some recommendations for consideration for 2021 protocols including IN Midazolam, OB emergency guidance, cardiac management, pedi chest decompression/crics, newborn warmth management, pedi endotracheal intubation
 - c. Stork Pins
 - i. Awards continue, have seen an increase in prehospital deliveries
 - d. Statement of Health Equity
 - i. In need of developing a statement relevant for Maine EMSC program
 - e. NPRA
 - i. National survey of all hospitals for pedi readiness
 - ii. Postponed due to COVID, awaiting dates for resuming
