Summary 20-118: A patient complaint that the licensee failed to treat a patient after being requested by a BLS unit. The licensee then allegedly abandoned the patient.

MOTION: The Committee made a motion to resolve this case by offering a consent agreement with a warning; citing violations of Maine EMS Rules Chapter 11 §1(14); requiring a 100% QA/QI review of all the licensee's PCRs for a period of one year, conducted by a qualified individual not related to a service where the licensee is employed. The reviewer must be approved by Maine EMS staff, and the reviewer will report to the EMS Office quarterly. All associated costs will be the burden of the licensee. (Kellner, second by Drinkwater)

Summary 20-125: A patient complaint that the licensed service does not have the necessary pediatric medical equipment. The decision-making ability, standards of conduct, and transport policy at this department are also in question.

MOTION: The Committee made a motion to table this case to allow the Service to provide the following documents for review at the October meeting:

- QI plan outlining who will be responsible for reviews, what calls will be reviewed, etc.
- Training plan mandatory training for the involved personnel, at a minimum, specific to the issues cited.
- Transfer of care policy outlining how the service expects clinicians to transfer patients between levels of care, specifically downgrading care.
- Mutual aid policies outlining when and how clinicians are expected to request mutual aid, and factors for determining the most appropriate resource to request.

• Inspection policy – clearly defining roles and responsibilities of all staff.
