    - 1. This has been completed.

## b. PIFT

- i. Rick Petrie
  - 1. Had a PIFT meeting yesterday with Dr. Tilney. He's been looking at materials that subcommittee put together.
  - 2. Tremendous discussion on 2 separate issues
    - a. Education update- outdated
    - b. Significant amount of inappropriate transports happening under PIFT.
  - 3. Two completely separate issues that need to be dealt with separately.
  - 4. At next MDPB meeting, Dr. Tilney to speak on recommendations:
    - a. Sunset PIFT and put onus on services and hospitals to develop program
    - b. Update PIFT as it is with current education and address inappropriate transport separately.

  - Asks, can we at least get updated education out? How do we avoid this taking a back seat while system issues are being worked out?
  - Rick Petrie committee agreed that not only would options be worked up, but Pete would get his education modifications to MDPB so that they could be implemented.
