Subject: Announcement of 2021 Protocol Update Training

What

Maine EMS will begin utilizing updated Statewide EMS protocols on December 1, 2021 at 12:01 am. All Maine EMS clinicians must complete a protocol update session. Clinicians will have TWO options for completing this update.

Option 1

Maine EMS will be holding six (6) online sessions for the 2021 Maine EMS Protocol Updates, presented via ZOOM webinar. Due to COVID, *there will be no live, in-person sessions*. As in the past, there will be one session per EMS Region, and will be led by state EMS Directors Drs. Matt Sholl and Kate Zimmerman, and the Regional Medical Director for each specific region, with additional support by Maine EMS staff. In addition, the Regional Medical Directors for the Region being highlighted will have the opportunity to specifically discuss the changes for the sections they authored. Clinicians must attend the entire session for credit.

Option 2

Protocol updates will also be presented on the MEMSEd LMS. **EMS clinicians need only complete** *ONE* **of the courses** for CEH credit- EITHER the ZOOM online webinar OR the MEMSEd course, but not both. The MEMSEd course will be available towards the end of October, and access will be available by logging onto the MEMSEd site. Who

These sessions are open to all EMS clinicians, service Medical Directors, and hospital clinicians.

When/Where

All Option #1 sessions will be via ZOOM webinar and are online only. Session length is dependent upon attendance and participation. Participants should plan on 3 – 4 hours. SEE BELOW for dates and registration links.

• Though each session is directed at specific regions, **clinicians may attend any session they wish.** NOTE: CEH credit will be given for attendance at one (1) session ONLY. Attendance will be verified via the webinar software and you must attend the entire session.

- All attendees must register in advance, online, using the links provided. There is no registration by
 phone. In order to provide a better-quality webinar, attendance at each session is capped at 500
 attendees. First come, first served. If you are unable to register for the webinars due to capped
 attendance, you may complete the course on MEMSEd for CEH credit.
