MDPB Agenda – Meeting begins at 0900

- 1) Introductions -Sholl 0900-0905
- 2) Sept 2021 MDPB Minutes 0905-0910
 - a. Dr. Nash motions to accept the September meeting minutes. Motion is seconded by Dr. Zimmerman. No discussion. Motion passes
- 3) State Update 0910-0925 Director Hurley
 - a. Working with OBH for distribution of naloxone kits for service dispensation. Aiming to be accomplished before the end of the year. Training is completed. Will be putting this on MEMSEd asap. Training will take about an hour to go through. This training was developed in collaboration with a medical student from Tufts University.
 - Dr. Sholl discusses possibility of working with a second student on research projects related to this program.
 - b. Maine EMS is working on service center for the CP and systems of care coordinator.
 - i. This has gone to the DPS Commissioner. Working diligently on getting this online.
 - ii. Substance use disorder position will hopefully be available as well.
 - c. Maine EMS has applied for another grant to support the QI project that no one submitted a bid for.
 - d. Dr. Sholl adds conversations with the CARES group. They have 20 30% of the states enrolled. Maine is looking to get back into this somewhere around quarter 1 of next year.
 - i. Director Hurley- much of this is dependent upon extracting outcome data. Will most likely have to hire a contractor for data extraction. This was historically done via contract.
 - e. Directory Hurley also working on the physician field provider program
 - f. BLS Position Status- Dr. Sholl asks about progress sending the position back out for posting.
- 4) Special Circumstances Protocol Review NONE
- 5) New Devices-NONE
- 6) UPDATE Medication Shortages Nash / All 0925-0940

- a. Dr. Nash reports some issues with acquisition of epinephrine. Believes it is a packaging issue.
- b. Dr. Sholl shares work on development of a Maine EMS Formulary sheet, specific to 2021 protocols.
 - i. Has been working on this with Dr. Zimmerman, Dr. Nash, and Marc Minkler.
 - ii. This is about 75% complete. Par levels for medication stock being discussed.
 - iii. This would be added as an annex to the protocols
- 7) COVID-19 0940-0950 All
 - a. Dr. Sholl- admissions have gone up over the weekend.
 - b. Director Hurley Maine DHHS is having trouble procuring Binax NOW, DUE TO national shortages. So, they've acquired a separate test Carestart NOW. This test is a little bit different in how the user performs it. MEMS will be putting out a bulletin this morning. There is also a video illustrating how to use the test.
 - Dr. Tilney discusses hospital staffing issues. Working with hospital physicians and administrators to minimize impact on EMS.
 - d. Dr. Ritter- discusses staffing issues, as well as COVID volumes. Getting strained with requests for tests and not having personnel available to perform them.
 - e. Discussion of various service/hospital level coping mechanisms in the system. Discussion of diversion practices.
- 8) 2021 Protocol Update –All 0950-1100 2021 Protocol Education Discussion
 - a. Dr. Sholl discusses "go live" time and suggestions to push it back. Currently scheduled for 1 Dec. There is feedback that the system is already stressed and implementation on that date may stress it further.
 - i. Dr. Ritter discusses that this is one thing that came out of Region 2.
 - ii. Discussion.
 - iii. Dr. Meehan-Coussee asks Dr. Sholl about service-based protocol implementation. Dr. Sholl discusses a 3-month "ramp up" time for services to be trained on EMT SOP skills, meds, etc., while still letting protocols be implemented on 1 Dec.
 - iv. Dr. Meehan-Coussee motions to support Dr. Sholl's recommendation to have the 3-month flex period. Dr. Saquet seconds the motion, given that this is acceptable to the services concerned. Discussion by the group and stakeholders follows.
 - 1. Joanne Lebrun
 - a. I think our EMS system has taken the brunt of what's happened in the last few months. I'm grateful for any extra time allowed.
 - b. I think services and personnel need time to go back and absorb the materials put out.
 - 2. Sally Taylor
 - Agrees with Joanne. There is a substantial amount of education to be absorbed.
 - 3. The motion passes.
