  - i. PSEs

- 1. Exam updates took effect 15 April 2022
  - EMR and EMT cognitive exams available as onlineproctored exam with OnVue
  - b. EMT cognitive exams done via OnVue are now computer adaptive- as they are on the Pearson Vue testing centers
  - c. AEMT cognitive is only available at Pearson Vue testing centers
