- V. Public Comments
  - a. Sally Taylor gives Richard Shyduroff an opportunity to introduce himself and informs him of the purpose of this meeting. Mr. Shyduroff discusses his desire to learn about EMS education needs by attending various Maine EMS committee meetings.

#### VI. Old Business

- a. Exam scenario updates
  - i. Sally Taylor discusses.
    - 1. We are still working through this process. We are at about the 90% mark.
    - 2. Sally Taylor asks if the committee would still like the scenarios individual or as a complete package? Discussion.
      - a. Jeremy Damren recommends delivery as a package.
      - b. Rick Petrie concurs.
    - 3. Revisions have been done to at least 9 of 11 of the scenarios. Sally Taylor inquires about past suggestion to remove mushrooms from the scenario package.
      - a. Joanne Lebrun discusses aspects of how the scenario could be improved. The main issue with the scenario is that parts of it are so vague. Also, how the scenario depends upon how the examiner perceives the scenario and how it is portrayed.
      - Sally Taylor suggests that the scenario (#5 Environmental) be removed from rotation. Ben Zetterman makes the motion. Seconded by Rick. Motion is carried.

### VII. New Business

- a. Verification of psychomotor skills at the EMR/EMT levels for re-entry candidates
  - Discussion of maintaining a PSE for that purpose or finding a way to incorporate skills verification via skills portfolio summative examination battery.
- b. Specification of a sunset date for PSEs
  - i. Discussion.
  - ii. No specific date arrived at. However, it is estimated PSEs will be needed for both re-entry candidates and for another two years after the last course utilizing PSEs finishes.
