## IV. State Update:

- a. Chris Azevedo
  - i. MDPB ALS Representative
    - 1. There are eleven candidates. Six candidates were interviewed yesterday. There are five more to be interviewed. Goal is to have selection for February MDPB meeting.

#### ii. Bulletins

- 1. Maine EMS has recently issued three clinical bulletins:
  - a. Midazolam
  - b. High-Flow Nasal Cannula
  - c. Bronchiolitis FAQ

#### iii. Protocols

- 1. The next stakeholder forum is tomorrow at noon
- 2. Protocol sections which have been completed include:
  - a. Gold, Orange, Yellow, Green, Blue. Finishing up Red
- 3. Submission and feedback for protocol change suggestions has been good. Several approved changes came from providers.
- 4. Work continues on Pink and Brown/Black/Grey. Estimate reviews completed for April.

#### iv. NREMT

- 1. New online test items. Introduction as part of overall revisions for ALS and BLS examination processes.
  - a. Technology Enhanced Items (TEI). Utilize technology to deliver different question types besides traditional multiple choice. Idea is to enhance ability to bring decision-making evaluation questions closer to situations encountered in clinical practice

- c. Types
  - i. Build list
  - ii. Sequencing

  - iv. Check box
- d. These are item types which have been around in technology for some time but have never been incorporated into the NREMT evaluation process. Many services (including fire departments) have included these item types for some time in their own LMS courses and other blended competency and other evaluations.
- e. Maine EMS does not have the staffing or staffing expertise on board to support an exam like this.
  - i. This technology is great.
  - ii. In the future, it is hoped that we can incorporate items like this in our LMS training activities when staffing and budget allows.
- 2. AEMT Student Minimum Competencies Project

- a. An AEMT SMC Task Force consists of subject matter experts from NASEMSO, CoAEMSP, NAEMSE and the National Registry is a starting point of collaboration with State EMS Offices and AEMT educational programs to improve the evaluation and documentation of student minimum competencies with evidence-based guidelines.
- b. The Task Force has drafted the AEMT Student Minimum Competencies (SMC), a guidance document based on the Paramedic Student Minimum Competencies (SMC) template, using the National EMS Scope of Practice
- c. The AEMT Student Minimum Competencies advisory document will replace the psychomotor examination requirement once the new performance examination is in place on July 1, 2024.
- v. New Training Centers

    - b. NAEMSE Level 1 SMCC 28 30 April
      - Some confusion by a service chief on social media who thought this was a 16-hour Instructor certification course and got upset because she needed 24 just to renew her current license.
    - c. Requirements
      - i. Renewals after July 2022 will need 16 hours CEH, which is reduced from the former 24 hrs.

- vii. Lost Authorization To Test forms.
  - 1. If you are conducting PSE classes, please emphasize the importance of holding onto these forms.
  - 2. They call me with no information including old exam results. DIFFICULT.

  - i. Started national EMS pediatric education survey that focuses on types, amount of pediatric education is happening throughout state and nation.
