- 4. Modifications to the agenda
 - a. None
- 5. Approval of Meeting Minutes
 - a. January 12,2023 Meeting couldn't motion as there was no quorum present
- 6. Old Business
 - a. Attendance

i. Dr. Lowry discussed the plan the committee had consensus on at the January meeting. Dr. Lowry will send out an email after this meeting to individuals who missed both January and February meetings to make a plan for attendance.

b. Goals for the year

- i. Does the committee want workgroups/assignments?
 - 1. Committee discussed goals moving forward and suggested working as a whole committee due to the size.
 - 2. Walter discussed the importance of finances in future goals and wanting to further discuss what grants/money are available to make CP feasible.
 - 3. Dennis discussed sustainability and the importance of focusing on long-term sustainability. He suggested waiting for the scope to be passed to discuss data.

ii. Data

- 1. Charlie spoke about collecting hospital readmission data as being important for cost analysis.

- 3. The committee discussed having a potential walkthrough of the Imagetrend CP module in a coming meeting to have a better understanding of what the data should look like.
- 4. Darren stated that it would be important to define the need from the data and to define questions you want to answer.
