V. Investigations

A. Camden Fire Department Application

Summary: Camden Fire Department is applying for a new non-transporting ground ambulance service license at the EMR level, permitted to provide Paramedic level care on some calls. During the application process it was discovered that the applicant, who does not have an EMS license, responded to a medical call for service. Upon inquiry, it was discovered that the applicant routinely responds to medical calls for service.

MOTION to recommend that the Board grant the license. (Drinkwater, seconded by Turcotte)

B. Case 22-254 Informal Review

Summary: The licensee is alleged to have performed a skill for which they are not licensed or qualified to perform, and it is further alleged that the licensee did not inform the EMS clinician responsible for overall patient care that the procedure delegated to them was not in their scope of practice. This case was initially presented to the Committee on January 26, 2023 and tabled to allow the Investigator to gather additional facts.

MOTION to recommend the Board resolve this complaint with a letter of guidance citing the importance of acting within the scope of practice at the level they are licensed; to be kept on file for two (2) license cycles. (Giberson, seconded by Gerrish)

C. Case 22-252 Informal Review

Summary: The licensee is alleged to have inaccurately recorded and/or omitted material facts from a patient care record and to have violated applicable standards of patient care.

E. Wallace Application Review

Summary: An applicant for a new EMT license failed to disclose a history of a criminal conviction of Class D Criminal Mischief in October of 2013.
