 - i. On March 15, Brent Libby approved this addition to the committee.
- b. Pediatric Newsletter
 - Chip reviewed the topics proposed in last month's newsletter and forwarded them to Marc. Marc presented some of the topics of the newsletters.
 - ii. Melissa asked if there were questions they could answer through EMD Data. It is important to identify those items early because there is no aggregated database for EMD data, so querying the data takes longer.
 - iii. Marc discussed some items that jumped out to him no transports keep him up at night. 25% no transport rate for patients under 18. 1 in 4 do not get transported; when we compare that to patients over 18 is a 14 percent no transport rate, we are uncomfortable with PEDs as they only represent 5



% of our call volume; BRUE is hard because it requires outcome data from hospitals.

- iv. Transporting separately from Mom, what does this mean -
 - 1. Not in Mom's arms.
- v. Sally brought up the pediatric no transport, what the risks are, do we follow the protocols.
- vi. Alan Henschke spoke about pediatric no transports MVC law enforcement requesting an evaluation for minor crashes.
- vii. Is the right pathway being followed to get to that decision
- viii. EMD Perhaps choking, respiratory arrest, or cardiac arrest. Newborn deliveries.
 - ix. Newborn delivery instructions after delivery from EMD. Placing the baby between the legs is not the best choice
 - x. Chip asked about what we have for data on keeping babies just born warm and dry.
 - xi. Brian Langerman one of the things he deals with is mental health for pediatrics.
 - 1. Refusals

 - 3. Weight-based medication dosing
