- V. Investigations

A. Case 22-221; Informal Conference, Licensee Present

Summary: It is alleged that the licensee failed to conduct at least one (1) training course required for Maine EMT scope of practice expansion in accordance with training center standards and falsified training documents.

Tim Beals recused himself and was placed in the waiting room.

information regarding case 22-221. (Giberson, seconded by Gerrish)

B. Case 23-272; Case Review

Summary: It is alleged that the licensee yelled at and made disrespectful comments to and about the staff at a nursing facility in front of a patient and also delayed the transport of that patient while making staff search for and then berating them for not having a non-rebreather mask for the patient.

Action:

MOTION to recommend the Board dismiss this case and forward the complaint to the service that the clinician was responding with at the time of the call. (Giberson, seconded by Drinkwater)

C. Case 23-275; Case Review

Summary: It is alleged that the licensee permitted covered emergency medical services persons who have elected not to receive a COVID-19 vaccination and do not have an approved medical exemption, to provide direct patient care.

Steve Smith recused himself and was placed in the waiting room.

Action:

MOTION to recommend that the Board direct staff to set a hearing on this matter; in lieu of a hearing, the Board will offer a consent agreement to resolve the complaint with a warning and acknowledge that the service has taken the necessary steps to comply with Chapter 21 of the Maine EMS Rules, including suspension of personnel who could not demonstrate a certificate of immunization or documentation of exemption and providing a record of immunization status for all covered emergency medical services persons associated with the entity to Maine EMS; the

Board also recognizes a change in service leadership as a mitigating factor. (Giberson, seconded

by Gerrish)
