### 4. Public Comments

Ben Wallace – Appreciated the exemption of ambulance operators in the draft Chapter 21 proposals. Expressed concern with the proposal to add vaccinations as some members of his workforce would need to be tested as they might not have records, and that would be an expense.

James Seymour – Spoke in support of the Chapter 21 proposals, as it would help with staffing issues within their department.

Chief Rich Kindelan, Scarborough FD – Spoke in opposition against any vaccination mandates. Expressed concern with the proposed November date for influenza vaccinations, as it is quickly approaching.

M. Devoid – Described a personal reaction to the COVID-19 vaccine and cited a several-month recovery period. Would like providers to be able to choose whether they have vaccinations.

Deputy Chief Leach, Augusta FD – Lost four providers due to the mandate, some would like to get back into EMS if the COVID-19 portion of the rule were removed. Some providers in the department also expressed concern over the influenza vaccine.

Chief Scott Soucy, Sanford FD — Encouraged the Board to drop the mandate, and let providers choose for themselves.

Dwayne Lee Philbrook – Had considered becoming a first responder department, but further vaccination mandates deterred them. Also cited costs of titer testing for staff.

Phil MacCallum – Expressed that the Board should not impose any vaccination mandates moving forward, but should provide education on vaccinations and allow providers to make their own decisions.

### a. Rulemaking

Chapter 21 Protocols
 Chair Libby provided an overview of the proposals for Chapter 21 as provided by the Rules Committee.

**MOTION** to repeal Chapter 21. (Beals, seconded by Whytock)

Discussion: Dr. Zimmerman – Vaccines are all very important as a public health service to protect those asking for help such as immune-compromised individuals and newborns. Dr. Sholl – Provided an overview of the COVID-19 vaccine efficacy. Discussed that in healthcare we also need to look out for the care of our patients. Andy Turcotte – Doesn't feel at this point we should be mandating the COVID-19 vaccination but thinks the masking agreement is important to ensure the safety of our patients. Bill Cyr – Agrees with Dr. Zimmerman and Dr. Sholl; the role of EMS professionals is to protect themselves and the patients they take care of. Feels the list of additional vaccinations is reasonable and many providers will have already received them through school, for clinicals, or other work-related reasons. Chair Libby – Spoke on how we created good habits because of COVID-19 but would like to see improvement with documentation of patient care and protection. Stressed providing good care to our citizens. Judy Gerrish – Agrees with Dr. Zimmerman and Dr. Sholl and mentioned that regional medical directors spoke at the rules committee and echoed their comments. Chris Whytock - Mentioned other steps that can be taken to protect patients, such as sending sick staff home. Dr. Sholl – Cautioned against just sending staff home when they are sick because diseases can be transmitted prior to the appearance of symptoms.

Director Hurley recommended putting forth the most advanced option to the public for comment, as it could be changed because of public comments received. AAG Samantha Morgan advised that if the language were changed significantly during the rulemaking process, it would have to be sent out again for public comment. Tim Beals felt this could lengthen the rulemaking process.

**MOTION** to propose Chapter 21 – Vax Add draft to go out for public comment and to include an amendment to exempt ambulance operators from the rule (Cyr, seconded by Smith)

Discussion: Chair Libby would like to amend the implementation date to the date of hire. Director Hurley mentioned it would be very difficult to operationalize due to the movement of individuals in the system. Bill Cyr declined to amend the motion.

### b. Stabilization Allocation Formula

Director Hurley discussed that the \$31 million goes into effect October 25<sup>th</sup> and would theoretically be available October 26<sup>th</sup>. The office is working with the Governor's Office and DAFS to get financial orders in place for the funding. The sustainability portion of the program will require rulemaking. The group discussed using either the USDA or CMS morality scores in the allocation formula.
