• Collaboration TTY: (207) 287-3659 Summary: The applicant for a new Ambulance Operator license failed to disclose criminal convictions for Misuse of Public Benefits Instrument, a class D crime, and Theft by Unauthorized Taking or Transfer, a class E crime, in 2016. The Committee recommends the Board preliminarily deny the application, citing unprofessional conduct rules and that the applicant has not demonstrated sufficient rehabilitation to warrant the public's trust.

c. 23-301 Case Review Bill Cyr recused and left the room.

Summary: The licensee allegedly did not complete the required clinical training during their Paramedic licensure course and falsified training records. The Committee recommends the Board dismiss the complaint citing lack of sufficient evidence due to the time lapsed from when the alleged violation took place.

d. 23-317 Case Review

Summary: The licensee failed to ensure the documentation of at least 57 EMS calls for service, in an electronic Maine EMS patient care report. The Committee recommends the Board preliminarily deny the renewal application and offer a consent agreement to issue the license with a censure and probation for one (1) year, during which time the Service Chief or Training Officer must coordinate and ensure all personnel complete a documentation course with a MEFIRS component, at least two hours in length, and the course must be preapproved by the Maine EMS Education Coordinator. The service must also submit quarterly QA reports to the investigator during the probation period, demonstrating they are meeting their target items for FY 2024 reported in their QA plan.

b. Community Paramedicine – Vehicle Branding

The Board discussed whether services with Community Paramedicine designations that brand their vehicles with the phrase "Community Paramedicine" or "Community Paramedics" but are not licensed at the paramedic level advertise themselves as providing a level of care other than that at which they are licensed.

**MOTION** to interpret Chapter 3, Section 7(3) of the rule to allow all services with Community Paramedicine designations to brand their vehicles with "Community Paramedicine" because that designation is not license-level specific. Use of the term "Community Paramedics" by a service that is not licensed at the paramedic level, however, is potentially deceptive or confusing to the public as it may indicate the service is licensed to provide care at the paramedic level. The Board discussed the terms "Community Paramedicine" and "Mobile Integrated Health," which would best describe current practices.

Community Paramedicine – Catchment Area

The board discussed the feasibility of approving a community paramedicine application that includes the entire state of Maine as the catchment area and how that could impact the development of community paramedicine programs in the future.

MOTION to direct the Maine EMS staff not to grant any community paramedicine plans that identify they will provide services beyond their current mutual aid agreements, and to bring those plans to the board for approval, and the applicants must provide public and agency notice.
