The committee recommends the Board offer a consent agreement for the licensee to surrender their Paramedic license with terms that the licensee agrees to never again apply for a Maine EMS license, citing 32 MRS §90-A. 5 (F) specifically violations of unprofessional conduct described in Maine EMS Rules, Chapter 11 §1 (5, 13, 14).

d. 23-320 Case Review

Summary: The licensed EMS service failed to ensure the completion of over 149 patient care reports for EMS incidents within the Maine EMS and Fire Incident Reporting System within 24 hours. The committee recommends the Board offer a consent agreement with

a warning and probation for five (5) years citing 32 MRS §90-A(5)(F) violations of unprofessional conduct described in Maine EMS Rules, Chapter 11 §1 (14 &23), and 32 MRS §90-A(5)(H) violations of Maine EMS Rules, Chapter 3§9 and Chapter 22§3(1). During probation, the service must maintain a quarterly measure of 85% ePCR submission within 24 hours and provide quarterly reports to the Investigator demonstrating that 100% of calls for service from dispatch logs have an associated ePCR in MEFIRS, all of the service's clinical staff must complete a documentation class each year – the class must be pre-approved by Maine EMS Staff, and all service administration must complete a MEFIRS administration and reports training with Maine EMS staff within six (6) months of execution of the consent agreement.

Discussion: The Board discussed whether asking for 85% of the documentation to be submitted within 24 hours was too lenient in this case.

Summary: The licensee allegedly engaged in or attempted to engage in unethical behavior that may be construed as misleading or deceptive. to recommend the Board offer a consent agreement for the licensee to surrender their AEMT license with terms that the licensee agrees to never apply for a Maine EMS license in the future, citing 32 MRS §90-A. 5 (F) specifically a violation of standards established by the NAEMT Code of Ethics.

#### f. Case 23-330

Summary: The licensee failed to comply with the terms of a consent agreement. The committee recommends the Board offer a consent agreement revoking the license with terms that the licensee agrees not to reapply unless or until they have completed a new licensure course.

#### h. Case 23-299

Summary: The licensee allegedly performed a skill they were not licensed to perform and, on a separate occasion, allegedly engaged in conduct that could be dangerous or injurious to other persons. The committee recommends the Board offer a consent agreement with a warning, citing 32 MRS §90-A(5)(F) violations of unprofessional conduct described in Maine EMS Rules, Chapter 11 §1 (5&30), and 32 MRS §90-A(5)(H) violations of Maine EMS Rules, Chapter 5 §3. Terms of the consent agreement include that the licensee must work with their Service Training Officer and, or Service Level Medical Director to create a course addressing the differences in the EMT and AEMT scope of practice in Maine within six (6) months of executing the consent agreement.

the procedure. The committee recommends the Board offer a consent agreement with a reprimand and suspension for at least thirty (30) days but not to conclude until the licensee has completed a preceptor or field training officer program pre-approved by the Investigator and one (1) year of probation following the suspension with 100% review of all patient care reports by a third party contracted with the licensee who shall provide a quarterly report to the Investigator regarding any accuracy in documentation or clinical care concerns, the reviewer must be pre-approved by the Investigator; any cost associated with the terms shall be borne by the licensee. Citing 32 MRS §90-A(5)(F) violations of unprofessional conduct described in Maine EMS Rules, Chapter 11 §1(14, 15, 33, 34).
