  - a. Investigations Committee June 23, 2024, Meeting Minutes

b. Case 24-349

Summary: The licensee did not disclose a criminal conviction on an application for licensure upgrade. Upon investigation, it was found that the licensee's conviction had been vacated and that the licensee had not reported the vacation of the conviction to the Board in writing within ten (10) days.

The committee recommends the Board preliminarily deny the upgrade application and offer a consent agreement with a reprimand and the upgrade, citing violation of 32 MRS §90-C. 1. B & D.

c. Pooler Application Review

Summary: The applicant for a new Ambulance Operator license has previously had their EMT license revoked, an application to relicense as an EMT denied, and must have all new applications reviewed by the Board. At the June meeting, the committee tabled the application to allow staff to gather more information about any steps the applicant has taken toward remediation and allow the applicant to provide letters in support of their

application with at least one from their employer. The applicant submitted an altered letter on behalf of his employer without their knowledge or consent.

The committee recommends the Board preliminarily deny the application and direct staff to refer the conduct to the District Attorney's office.

d. Case 24-339

Summary: The licensed non-transporting service allegedly responded to a request to transport a patient from a hospital to the patient's home utilizing an unlicensed service vehicle; the only licensed clinician who responded operated the vehicle, leaving the patient unattended with a family member in the back; and there is no documented record of this request for service or patient interaction in the Maine EMS electronic reporting system (MEFIRS).

The committee recommends the Board offer a consent agreement with a Warning and a recommendation that the non-transporting service remove the stretcher from their vehicle, citing violations of Maine EMS Rules, chapter 11 §1(26) Operating an ambulance or EMS vehicle that is not licensed or authorized by the Board and chapter 3, §11(1) Except as otherwise exempted by 32 MRS §82, no vehicle shall be operated as an ambulance (from within Maine) or emergency medical services vehicle unless it is licensed or authorized in accordance with these rules.

e. Case 24-350

Summary: The licensee allegedly obtained a patient's contact information while caring for the patient as the primary patient caregiver and, after completion of the call for service, attempted to solicit a date and/or initiate a romantic relationship with that patient using that contact information.

The committee recommends the Board offer a consent agreement with a Reprimand, Suspension of the AEMT license for 90 days for each finding with a maximum of one (1) year, and a consecutive period of probation during which the licensee must continue counseling with their established counselor with at least one (1) session each month and the counselor shall provide quarterly updates directly to the Investigator regarding the licensee's participation: citing violations of 32 MRS §90-A(5)(H) concerning Board rules Chapter 14 §4. Sexual Impropriety; and 32 MRS §90-A(5)(F), Unprofessional Conduct, specifically under Maine EMS Board Rules Chapter 11§1(12), (14), (37) & (38).

Discussion of the licensee's use of protected patient information for a purpose outside the care of the patient.

Discussion of adding a "fitness for duty" requirement from the licensee's personal mental health care provider, to ensure this behavior will not escalate into further abuse.

**MOTION** to accept the Committee's recommendation as submitted and to add that the suspension includes the licensee's Instructor/Coordinator license, as well as adds the requirement that prior to the end of their suspension, the licensee must receive a recommendation from a behavioral health provider as to their fitness for duty, and also provide evidence of completion of a Maine EMS staff-approved training on patient privacy protection, to be completed before the lifting of the suspension. f. Case 24-343

Drinkwater and Smith recused

Summary: The licensee allegedly urinated in the patient care compartment while making eye contact with the accompanying RN while transporting a patient on an interfacility transport.

The committee recommends the Board offer a consent agreement revoking the Paramedic license citing violations of 32 MRS §90-A(5)(F) Unprofessional conduct, specifically Maine EMS Board Rules chapter 11§1(5) & (14); 32 MRS §90-A(5)(B-3) A condition that affects the licensee's ability to provide emergency medical services; and 32 MRS §90-A(5)(E)(1) Inability to respond appropriately to a client, patient, or the general public.

Discussion of the concerning nature of the licensee's conduct, and the Board's options to effectively communicate its zero-tolerance stance on this behavior.

**MOTION** to accept the Committee's recommendation to revoke the licensee's Paramedic license and Instructor/Coordinator license, and add that the Board must review any future licensure applications submitted by this licensee. (Turcotte, seconded by Gerrish) (Yes) Allen, Cyr, Downing, Gerrish, Libby, Turcotte **Motion Carries**

g. Naloxone Leave Behind Protocol Training Non-Compliance

Summary: Licensees who are documented on a patient care report after December 1, 2023, when the protocol update was effective, and who had not completed the "Maine EMS Naloxone Leave-Behind Dispensation Training" on MEMSEd by July 1, 2024, were noticed of a complaint. Staff have proposed a timely and standardized resolution of these complaints when specific factors are present and have drafted a delegation of authority for this purpose.
