- b. Maine EMS Director's Update
 Given by Maine EMS Director Wil O'Neal.
 - i. Chapter 27 of Maine EMS Rules was signed into law as of February 25, 2025. Director O'Neal recognizes the Maine EMS Board, Staff, and legal counsel for the quality of their work on this. The public will be notified of the funding opportunity on March 12, 2025, with an open date of March 17, 2025 for grant applications, pending Board approval to open the application process.
 - ii. The Maine EMS podcast has aired its second episode and is available on Spotify.
 - iii. Legislative updates:
 - 1. LD871: An Act to Exempt All Persons, Including Health Care and Emergency Services Personnel, from COVID-19 Vaccine Requirements was brought up for the Board's awareness.
 - 2. Board members are asked to let Director O'Neal know when there are any bills that are of interest to them that they would like to be discussed at future Board meetings.
 - iv. There is currently a measles outbreak, which has spread from Texas to New Mexico. There have also been two cases in New York City and three cases in New Jersey. Maine EMS is working with Dr. Sholl on issuing a clinical bulletin on this issue.
 - v. The Community Self-Determination Grant application process has closed. Five grants totaling \$200,000 will be awarded, with over 20 towns looking to collaborate between the funded projects. There is currently a bill before the legislature sponsored by Senator Curry that would make \$200,000 available to continue the grant for the 2025-2026 fiscal year (LD583: An Act to Support Informed Community Self-Determination in Emergency Medical Services Planning).

- c. Medical Directors' Update
 - Given by Statewide Medical Director Matthew Sholl.
 - Dr. Sholl gives an update on the review of MDPB Protocols, thanking everyone who has worked on this for their efforts. A rollout date of December 1, 2025 is anticipated.
 - ii. Pilot Project Updates:
 - 1. Sanford went live with their project to use ultrasounds to place IVs at the end of January/beginning of February. They reported out on three cases so far.
 - 2. Regarding the Delta stable-vented-patient project, there has not been a pilot project patient in several months (i.e., they have not seen a patient who has been exclusively managed by Delta staff or the team that Delta has trained). There have been many cases in which the patient has been co-managed by Delta and hospital staff during IFT.
 - iii. Events being tracked:
 - 1. National Cyano Kit shortage—A bulletin has been issued. Dr. Sholl gives special thanks to those who responded to the Northern New England Poison Control Center to offer their support and resources.
 - Hemorrhagic fever in the Democratic Republic of Congo—There have been a number of cases of a virus akin to Ebola or Marburg. Testing shows it is either a mutated strain or a novel virus. There has not been any spread outside of the DRC.
 - 3. Measles—A bulletin is in progress, and Dr. Rachel Williams created and shared an informatic white paper with MDPB which is being personalized for EMS clinicians and will be released imminently. Cases have mostly been contained to the Southwest in communities where there have been exemptions for vaccination (roughly 93% of cases were in individuals who were not vaccinated). Cases have spread to New York, New Jersey, Rhode Island, and Washington state, likely due to international travel to communities that had outbreaks.
 - iv. A clinical bulletin regarding OB closures is nearly ready for dissemination. The purpose of the bulletin will be to raise awareness about existing protocols, educational opportunities, and available resources, as well as encourage communication between services and hospitals. More OB closures are anticipated in Maine, and 46% of hospitals do not currently have OB services. Special thanks is given to EMS Staff Marc Minkler for his work around this, interfacing with the OB and pediatrics communities.

- c. Lisbon Emergency Vehicle Lettering Waiver Request
 - i. Lisbon Emergency, a private, non-profit ambulance service, is the transporting service for Lisbon, Bowdoin, and Bowdoinham. They are proposing an 18-month trial merger with the Lisbon Fire Department to provide services within the town of Lisbon. The merger would involve the use of the town's ambulance, which would be leased to Lisbon Emergency. They are seeking a waiver from the Board specific to the lettering of the town's vehicle, which says Lisbon Fire Department, for Lisbon Emergency to be able to use it for transporting purposes for the duration of the 18-month trial period. There are two citations (Maine EMS Rules, Chapter 3, §11.5.A. and §13.1.L.) which would require the vehicle to be lettered or have the logo of the agency, which in this case would be Lisbon Emergency.

 - i. EMS staff member and ConnectME Program Coordinator Anna Massefski recognizes the achievements of the first cohort of Learners in the EMS ConnectME program, which rolled out just over a year ago. Massefski shows appreciation for the services and Mentors participating in the program.
 - ii. John Mason, Chief Strategy Officer at JMG, an educational non-profit serving over 12,000 students in Maine-based public schools, colleges, and universities, spoke to JMG's role in the ConnectME program, thanking program participants.
