    - i) The RFA received 14 applications and 10 agencies were conditionally awarded. There is a 15 day appeal period and then contracts can be signed.

- i) There is a position that was included in the budget that would be half time CP and half time CCT. The budget is being reviewed by the legislature and they ultimately make the decision on whether to approve positions. If this position is approved we could look at hiring for this beginning of the fiscal year which start July 1<sup>st</sup> of 2026.

  - i) Jason Oko provided a walkthrough of the CP conditional licensure application within e-licensing.
