7. Old Business:

- a. Performance Measures
 - a. How do we move this down to a few measures?
 - i. Dr Sholl NEMSQA -
 - 1. Dr Sholl spoke about his recent work with NEMSQA.
 - 2. Jason Shared a link to the measures: https://www.nemsqa.org/nemsqa-measures
 - 3. Director O'Neal, crosswalk the measures from Chip's list to NEMSQA and determine the system's needs.
 - a. EMS to Balloon time, 12 lead transmission
 - 4. Are some of these items already being measured by external resources, STEMI registries, etc.? How do we connect with those entities?
 - 5. What we do matters. Our documentation is essential.
 - ii. Chip
 - 1. Let's crosswalk this list to NEMSQA
 - 2. Some things may not be measurable until you get down to the local chart review.
 - 3. Continue work on QI Manual in offline mode.
 - iii. Jason
 - 1. Can we build these to be systemic and then narrow them down to the local level by making them more granular?
 - 2. The NEMSQA measures and more are available in biospatial.
 - iv. EMS to balloon overcoming resistance to this as a metric. The data may make folks uncomfortable.
 - 1. Matt, this could be an issue, but they are asked to report from first medical contact, which is EMS in some instances.
 - 2. Local Cath labs want to have influence over system design to grow and evolve. To work with agencies to determine the best model for their community



- v. John DeArmond Does the data capture 12 lead, does it capture aspirin and nitro admin, etc.?
- vi. Build one measure out from start to finish and create educational content about it.
- vii. Jason Cooney When was the last time the QI Manual was updated?
 - 1. Need to update that manual. Goes hand in hand with the standards to measure things.
 - 2. Chicken vs. Egg Start with the manual and the education piece.
- viii. Melissa EMD has a great QA process, it is easier with recordings.
 - 1. In addition to the manual, we could also provide some templates for focused reviews that can be utilized for QA/QI.
