Rose proposed removing the bullet, stating "Convictions for which incarceration for less than one year may be imposed and which directly relate to the trade or occupation for which the license or permit is sought."

Kelner proposed to approve the delegation of authority through the next EMS Licensing Board meeting, where staff will present data available regarding the historical use of the delegation order.

Amended MOTION to approve the delegation of authority, striking the language quoted, with an expiration date of November 20, 2025, and a scheduled reevaluation at the next EMS Licensing Board meeting.
