- 3) Impose a probation or a period of one year, or until the completion of the following conditions and upon the Licensee's successful petition to this Board for the early termination of probation, whichever is sooner:
 - i. Continued mental health treatment for no less than six appointments with the Licensee's current provider;
 - ii. Provide the Board with a signed letter from his provider documenting his treatment and certifying his suitability for continued practice as an AEMT and AEMT/IC; and
 - iii. Completion of 16 hours of NAEMT continuing education in ethics and four hours in HIPPA; and
- 4) Until completion of the probationary conditions and upon successful petition to this Board for early termination of probation, the Licensee shall not engage in any EMS teaching, instruction, or coordination.

- b. Case 25-940
 - i. Summary: The licensed Paramedic failed to properly care for a patient who was either in cardiac arrest with pulseless electrical activity (PEA) or experiencing symptomatic bradycardia. The Board finds the Licensee's actions and/or omissions constitute a violation of 32 M.R.S. §90-A(5)(H) and Maine EMS Rules, Chapter 5 §3(2)(B) and §4(A), for violating the standards of practice for a Paramedic based on the Maine EMS Pre-Hospital Protocols and the National EMS Scope of Practice Model, 2019 edition; and 32 M.R.S. §90-A(5)(E)(2) for incompetent professional practice as evidenced by an inability to apply principles, skills or knowledge necessary to successfully carry out the practice for which the licensee is licensed, specifically the ability to apply the principles, skills or knowledge necessary to practice at the Paramedic Level in cardiac rhythm interpretation, clinical care of cardiac arrythmias, and clinical decision making, despite undergoing additional remediation on these topics.

- b. Medway Fire Department Application Review
 - i. The Medway Fire Department has applied to upgrade their license from non-transporting to transporting. Medway's Fire Chief, Aaron Lee, provided the Board with data it had requested during its last regularly scheduled meeting. The Board also heard from the Fire Chief of East Millinocket, Kevin McAdam.
 - ii. Pursuant to the Maine EMS Rules Chapter 3 §4.2., "The Board shall issue a license with a defined 9-1-1 Primary Response Area when a need is demonstrated based on the following criteria..." The Board reviewed Maine EMS Rules Chapter 3, §4.2. and discussed whether or not a need is demonstrated based on the criteria outlined in that subsection:
 - 1. The Board finds the applicant's proposed response time(s), enroute time(s), transport time(s), and time-tolerance(s) are sufficient to protect the health, welfare, and safety of the public within the 9-1-1 Primary Response Area based on evidence provided;
 - a. **Board Response:** Yes.
 - 2. If the 9-1-1 Primary Response Area is currently served by a licensed ground ambulance or non-transporting service, the proposed times above are maintained or improved;
 - a. **Board Response:** Yes.
 - 3. Public comment(s) received;
 - a. Board Response: Yes.
