person with an exemption must receive a binax now test three times per week or at the start of each scheduled shift whichever is less if that person is available to emergency medical calls. And further, to pass a resolution that the Board send it's request to Maine CDC and DHHS to consider involving Maine EMS stakeholders in the review of their formal rule as they go through the rulemaking process or at a minimum limit the scope to include those that participate in direct patient care for 15 minutes or more within six feet or less from any patient. Also that DHHS and the CDC look at potential alternatives to vaccination for those that may have a need or an exception.
