3 Functions





- Paramedic
 - Tiered 911 ALS
 - IFT
 - Community
 Paramedicine
 - Community health needs driven CP

- RHCT
 - Workforce support for FQHC
 - Delegated practice "MA" work

- CAIP
 - Off hours
 - Facilitated telehealth
 - Could also occur as part of 911 response

Potential Telemedicine Encounters

- 215 potential telemedicine encounters
- 145 telemedicine encounters completed
 - 2% (3) of cases patient referred to ED during encounter
- 70 potential telemedicine encounters not initiated
 - 51% (36) physician deemed not appropriate for telemedicine
 - 13% (9) CAIP deemed not appropriate for telemedicine
 - 31% (22) patient declined telemedicine
 - 4% (3) connectivity issues
- 144/145 cases occurred at ambulance base

Outcomes

HealthInfoNet and patient follow-up calls as source of truth

No complications of CAIP visits identified

19,409 patient travel miles saved

30-day follow-up with PCP

- 32 total
 - 22 related to CAIP visit
 - 9 unplanned
 - 0 unexpected

30-day visit to ED

- 5 total
 - 2 unplanned
 - 1 not related to CAIP visit
 - Other not unexpected

30-day admission to hospital

- 4 total
 - 2 unplanned
 - 1 not related CAIP visit
 - Other not unexpected
