# **Community Paramedicine Affiliate**

The Maine EMS department, regional EMS offices and EMS training centers can serve as resources for both content expertise and equipment. The goal is to prepare EMS providers at all levels to proficiently provide entrylevel community paramedicine services within their respective Maine EMS scope and level determined by Maine licensure.
