Ready, Check, Inject Training Program

The *Ready, Check, Inject* training program is comprised of two separate elements that all providers must complete *before* utilizing the new protocol. The first element is a didactic presentation entitled "Ready, Check, Inject" available through your Regional EMS Office or the Maine EMS Office and taught by a qualified individual. The second element is a brief psychomotor competency designed to be completed at the service or Regional level. Services who intend to utilize the Ready, Check, Inject project are required to document completion of both elements of the training program for any EMT who intends to administer epinephrine by syringe. Services are required to maintain documentation (CEH certificate/roster and skill sheet) of program completion and produce the documentation if requested by Maine EMS.

Psychomotor Training:

- This document outlines the supplies, objectives and procedure for the practical training of the Ready, Check,
 Inject program. To become approved to administer epinephrine via syringe EMTs must first complete the
 Ready, Check, Inject didactic presentation, then successfully complete the psychomotor training.
- The psychomotor training must be overseen by a qualified provider and competency in the procedure must be reviewed by an Advanced EMT, Paramedic, Physician, Physician Extender, or RN.
- Practical evolutions may be repeated as many times as necessary to obtain competency. Facilitators should not
 approve candidates until they feel comfortable that the EMT can safely and competently administer epinephrine
 via syringe without supervision.
- Training Materials Required:
 - O Ready, Check, Inject Instruction card
 - O 1 mL syringes (including epi-safe syringe from Curaplex)
 - Services may use expired and/or previously opened clean syringes and needles (for training only).
 - o 1" safety needle
 - Services may use expired and/or previously opened clean syringes and needles (for training only).
 - o 1" Filter Straw
 - For Use with Ampules
 - Vial and Ampule of medication
 - Services may use expired or previously opened medication vials (for training only). 10mL vials/ampules of normal saline offer a low cost alternative if expired medications are not available.
 - O Injection trainer or suitable alternative to perform IM injections.
 - If an injection manikin trainer is not available, consider using fruit such as an orange or a lemon (analog) to simulate the intramuscular injection.
 - O Alcohol prep pads
 - Sharps disposal container
 - o Gloves
- Psychomotor Objectives:
 - O List the supplies necessary to complete a *Ready, Check, Inject* intramuscular injection.
 - o Demonstrate the ability to correctly withdraw medication from a vial and ampule.
 - O Demonstrate the ability to utilize the *Ready, Check, Inject* resources to prepare a proper dose of medication for both adult and pediatric patients.
 - O Using an injection trainer or suitable alternative, demonstrate safe technique when administering an intramuscular injection.
