- 1. Call to Order The meeting was called to order at 9:35 a.m.

- 2. Minutes June 19, 2014

Members reviewed minutes from June 19, 2014 meeting, for approval.

- 3. Staff Reports
 - A. Maine EMS Update

Drexell reported:

- The Maine EMS Quality Assurance and Improvement Committee has completed work on it Cardiac Arrest study. The QA & I Committee will be releasing a report about the study in the near future. The study illustrates the importance of EMD pre-arrival instructions and lay person CPR as part successful resuscitations
- The semi-annual Q review was held at the Maine Criminal Justice Academy in Vassalboro on September8th, with Ken Hotaling from Priority Dispatch Corporation. Ken discussed:
 - QA Standards 9a, changes;
 - Changes at the International Academies of Emergency Dispatch (IAED) that included a new Board of Accreditation and Council of Standards for Quality Improvement;

- Inclusion of Narcan administration in version 13 of the Medical Priority Dispatch System, due out in 2015; and,
- Use frequency of specific protocols as a percentage of total calls.

4. Old Business

A. Determinant Code Implementation

Drexell reported that he is developing a letter to EMS services clarifying what uses of the determinant code may be done at the local level vs. those requiring approval of a response assignment plan. He continues to visit EMS services as part of his EMD Center site visits to provide information and answer questions about determinant code use.

B. Standards 9a/AQUA 6 Implementation

QA standards 9a have been implemented by EMD Centers.

The committee briefly discussed the new accreditation standards (non-numerical) released by IAED.

C. Maine EMS Online Licensing

The bugs are being worked out of the online licensing system and Drexell is reviewing online licensing with EMD Center staff during his site visits.

5. New Business

A. EMD Refresher

The committee discussed the development of an EM<D refresher program for Maine EMDs. Currently the only refresher option is for dispatchers to attend a day or two of an initial class, which is focused at entry-level providers. Suggestions for a one-day refresher course included:

- Medical Legal
- Chief complaint choice
- Medical rational for specific protocols
- Infrequent calls
- Quality Assurance & Improvement
- EMD Jeopardy (after-lunch exercise)

A subcommittee consisting of Laura Downing, Dave Gardner, Peter Daigle and Drexell White will begin the development process and report back to the committee in November.
