Committee members requested that staff provide them with data on the breakdown of random station type for 2014 PSEs.

B. Aroostook Pearson Vue Site

Drexell reported that the Pearson Vue contracts will be reviewed by State Purchasing. There are several components within the Pearson Vue contract version that would not be accepted by the State (e.g., indemnification).

C. CPR Station and QI Committee Work on high performance CPR

Maine's focus on high performance CPR and how such training would affect PSE candidates at the Cardiac Arrest Management station were discussed. While high performance CPR training should not adversely affect a candidate's performance at the Cardiac Arrest Management Station, there is a potential for confusion. It was suggested that a Frequently Asked Question (FAQ) be created and added to the testing FAQs on the Maine EMS web site. Joanne and Drexell will work on the FAQ.

D. PSE Administrator Integration

The Committee discussed the possibility of integrating the PSE Administrator into the course itself in an ongoing evaluation process during the course of an EMR or EMT course vs. having the "State" Practical Skills Evaluation (PSE) at the end of the course. Committee consensus was that an integrated system would require as much if not more PSE Administrator time, along with examiner and programmed patient costs, and would not result in a monetary or in-kind resource savings, but rather a cost-shifting.

Discussion continued about how to improve the efficiency of the current PSE process. One possibility discussed was removing the lengthy candidate and tester orientation from the beginning of each PSE and packaging the information in an online programs that could be viewed by candidates and examiners, and be verifiable to the Training Center. Eliminating the pre-PSE information delivery and replacing them with an abbreviated information and "any questions" segment should improve the time efficiency of the PSE. Also, candidates would have the ability to listen to the information in a stress-free environment vs. trying to absorb information just prior to PSE commencement.

Staff will check on the feasibility of including such programs in the Maine EMS Online Learning Management System (MEMSEd).
