

MCOT November 7, 2018 • Focus on MCI with new guidelines from American Trauma Society. Christopher Hunter, MD will speak (Medical Director involved with the Pulse Night Club shooting) Trauma Coordinators & Dr. Fenwick are organizing the other presentations **Stop-the-Bleed initiative** • Anna Moses has had great success with her grant writing. EMMC has been involved in teaching Cianbro employees, high schools/nurses. Has had many students go on to teach their own classes. Rick Petrie: working with the legislature and a group from the Public Safety building. Dr. Rappold: Could the next MCOT topic be on bleeding control technologies? Joanne LeBrun: Many schools are building their own kits and placing in classrooms where they are readily accessible. Placing them with the AEDs does not allow easy access in a lockdown/active shooter situation.

Technical Assistance Program/RTTD	 Redington-Fairview July 11, 2018 Well received Dr. Comis was interested in a guide for transfers. Pen Bay Medical Center Continue to try to generate interest for TAT. Difficulty with scheduling due to this. Other areas have been identified – i.e. hospitalists would like more education on the inpatient management of trauma patients. Trauma Coordinators are working on this. MMC has offered their protocols. Tammy Lachance discussed an elderly trauma protocol which may be helpful for them given their older population. Consider Telemedicine as an option to help providers identify those patients with confidence that are safe to stay at the local hospital. Calais, DECH, Inland A lot of turnover that has occurred which has interrupted the ability to reach out. 	 Guide for Transfers – next step? Trauma Centers will continue to work with Pen Bay re: their needs. Dr. Zimmerman will continue to work with outreach to Calais, DECH and Inland hospitals.
Trauma Directors Meeting Update	Discussed struggles with volume/capacity in the hospitals and the fact that Critical Access hospitals cannot keep their patients for more than a 3-night stay.	
Trauma System Operations Manual	Dr. Zimmerman would like to review and revise the current manual. Group is in favor of this.	Dr. Zimmerman to work on a revised draft and present to the group.
Other Business	 Project/Research updates Moose Study – CMMC & MMC to contribute; looking for EMMC as well (they need a copy of the research protocol). C-Spine – IRB pending Minor Head Injuries – Dr. Fenwick reviewed their local cases, looking to support their outlying hospitals in keeping some of these patients local. MCI Incident Management – Include Emergency Preparedness and Regional Resource Centers. Review Membership list 	 Dr. Zimmerman will: Work on recruiting members to fill the vacant positions. Reach out to the EMS-C coordinator and invite him to the meetings. Provide an updated membership list at the next meeting. Dr. Zimmerman will fix the spelling errors in the TXA paper and have MEMS re-post.
