Re: Supplemental Memo for One Maine PAC Leadership PAC Review

As part of the Commission staff's findings for One Maine PAC (the "PAC"), I believe that One Maine was late in filing an Independent Expenditure Report and recommend a \$750 penalty. The PAC, in its response, indicates that it could not have filed an Independent Expenditure Report when it was initially invoiced because it "didn't need to report the IE until the product was completed and final payment invoiced." In supporting this conclusion, the PAC indicated that "We did not know yet how many and which districts would ultimately receive an independent expenditure and therefore could not report the IE." It should be noted that the PAC received an initial invoice on 09/22/2020 and reported the IE as a 10/14/2020 expense; the filing period for the October Quarterly ended on 09/30/2020.

I am unpersuaded by the PAC's argument regarding this issue; however, Director Wayne has been persuaded. We have attempted to reconcile our positions but have been unable to. We have come to the conclusion that the Commission would be best served by both of us outlining our positions and allowing the Commission to weigh the arguments.

My understanding of Director Wayne's concerns is that it would be unfair to the PAC to require it to file an IE Report prior to knowing which races it will attempt to influence and that the report would be confusing to the public. I do not disagree with Director Wayne's concerns, however, I believe that accepting the PAC's contention would create a significant loophole in the reporting of IEs, would increase the reporting burden on the PAC, and result in more confusion for the public in reviewing the reports.

Director Wayne and I agree that under 21-A M.R.S. § 1052(4), an expenditure is made when the obligation to pay has been incurred. There is no disagreement that the

obligation for payment existed as of 09/22/2020 because the PAC was invoiced by the vendor. There is also no disagreement that the PAC knew that the expenditure was going to be used as an Independent Expenditure.

I find it unlikely that the PAC would have spent \$8,283.54 with no idea how the funds would be used. I find it reasonable that the PAC did not know the full extent of who they would be supporting and by how much, but I would suspect that the PAC knew of some candidates that it would probably be supporting. I agree with Director Wayne, that the Commission could use the 07/30/2021 meeting to investigate what the PAC genuinely knew at the time.

By allowing a PAC to change the date of an independent expenditure based on when they knew which candidates they were going to support, the Commission would create a significant reporting loophole: regardless of when a payment is made, a PAC would not have to file an IE until they had determined the candidates who would appear in the communication. This delay prevents the public from obtaining accurate information, prevents opponents from being able to plan and respond to IEs, and allows PACs to hide their expenditures until much later (in this case three weeks later, when the report should have been filed within 2 days).

In addition to this loophole, the reporting would be more burdensome on PACs and less clear for the public. I have prepared sample reports that illustrate why this would be the case. The reports under the “Approach #1” heading is the process that Director Wayne would require and “Approach #2” is the process that I would require.

Director Wayne agrees that the expenditure should have been reported as of 09/22/2020 (October Quarterly) regardless of whether it should have been reported as an IE. This would require the PAC to enter an expenditure disclosing the obligation and file the report by its due date. Then, when the PAC determined the candidates to be featured in the IE, the PAC would have to delete that expenditure and refile the associated report. The PAC would then have to enter an IE with a new date (based on the PAC’s determination), file the IE, and then file the associated regular campaign finance report.

Under my approach, the PAC would enter an IE transaction based on the candidates that the PAC thinks it will most likely support/oppose. The PAC can then amend that one transaction to change amounts, candidates, etc. The transactions on the regular finance report would be automatically updated by editing this transaction.

Under my approach, the public would be able to review the amendment history for the IE in one place on the campaign finance website and be able to understand the history of the IE. The public, under Director Wayne's approach, would have more difficulty tracking unassociated transactions on an earlier report and linking them to the later IE with a different date. To the public, this approach would appear that the initial transaction was cancelled and that a second transaction occurred.

Lastly, if the Commission determines that an IE was not required for the reasons outlined by Director Wayne, I recommend that the Commission consider whether the PAC's October Quarterly report is substantially compliant. Director Wayne and I agree that the 09/22/2020 expenditure should have been reported on the October Quarterly. That report currently discloses \$7,811.55 in expenditures, meaning that \$8,283.54 was omitted from the report. In my opinion, having an error rate that exceeds 50% (as is the case here) would meet the substantially non-compliant provision of 21-A M.R.S. § 1062-A. I would recommend imposing a financial penalty of \$750 for this substantially non-compliant report.

Re: Comments on Potential Late-Filing Penalty against One Maine

This memo is to supplement Michael Dunn's excellent work on the leadership PAC compliance reviews with my own independent view on a possible late-filing penalty of \$750 against One Maine PAC.

During the course of the audit, we received an invoice addressed to One Maine PAC dated September 22, 2020 from Rocket Print&Mail/PostcardMania in the amount of \$8,283.54 for design work towards a mailing of 20,000 postcards. The mailing was not finalized and distributed to the public until at least three weeks later in mid-October. In his memo Mr. Dunn is recommending the view that the agreement to pay \$8,283.54 for design services on Sept. 22 required the filing of an independent expenditure report within two days.

The PAC responds that the work \$8,283.54 invoiced on September 22, 2020 was for design work only. It argues that: "No mailer existed at that point it was just initial design work. We did not know yet how many and which districts would ultimately receive an independent expenditure and therefore could not report the IE." The PAC has provided emails indicating that a member of the PAC's staff, Clarke Reiner, was presented with printers proofs on Oct. 12 and found an error. On October 13, 2020, the PAC corrected the mailing list for the candidate in House District 142. Mr. Reiner was presented with another proof on Oct. 15, 2020, and approved it. On that same day, Mr. Reiner provided to PAC treasurer Billy Thompson and Ryan Lorrain a list of specific candidates and expenditure amounts to be included in an IE report. The PAC filed the IE report on

October 16, 2020 showing that it spent \$258.14 to support each one of 37 candidates with a mailing.

An independent expenditure report is a special report filed by a person (usually a PAC or party committee) that is spending more than \$250 to advocate for or against a clearly identified candidate in a communication that is disseminated to the public, such as a mailer or a print or digital advertisement. 21-A M.R.S. § 1019-B. The report is required to “contain an itemized account of each expenditure in excess of \$250 in any one candidate’s election” The report must state whether the expenditure is in support of or in opposition to the candidate.

It is common for the state political parties and the caucus PACs to send mailings in *dozens* of legislative districts. If the PAC or party has spent money for a preliminary service toward mailings in many legislative districts but is *genuinely* unsure which candidates the mailings will support, my personal view is that it may be premature to expect an IE report under 21-A M.R.S. § 1019-B. My concern is that an IE report is required to contain specific amounts to support or oppose *specific* candidates. In order to be accurate, the IE report must accurately specify the candidates that will be supported or opposed in the communications. If a PAC or party committee were to report an expenditure to support State Senate Candidate X and ultimately does not make that expenditure, the filed report will be misleading to the public and to the candidates in X’s legislative district.

I recommend using the appearance by the PAC at the July 30 meeting to investigate *whether the PAC knew as of Sept. 22, 2020 which candidates it would be supporting* in the mailing. If so, it may be reasonable to apply 21-A M.R.S. § 1019-B to require an IE report by September 24, 2020. If the PAC did not know the candidates it would support, in this particular case I recommend exercising your discretion not to assess a late-filing penalty. I would also note that the amount spent per candidate was only \$8.14 more than the \$250 reporting threshold.

On November 18, 2020, the Commission authorized an enhanced compliance review of fifteen (15) political action committees that, in 2020, were led by Legislators and raised or spent over \$5,000 in the year. The Commission staff sent the Committee for One Maine PAC (the “PAC”) an initial request for records on 12/08/2020. ETH. 17-18. Those records were received on or before January 31, 2021, and a supplemental request for records was sent on 03/09/2021. ETH. 19. Upon reviewing the information provided by the PAC, the Commission staff found four potential violations and twelve exceptions. ETH. 13-16.

On 06/07/2021, the Commission staff mailed its preliminary findings to the PAC’s officers requesting comment. ETH. 11-12. The preliminary findings included potential violations for: (1) failing to report the correct payment for an Independent Expenditure, (2) a Late Independent Expenditure Report, (3) Failure to Update the PAC’s Registration, and (4) a Mismatch of Account Balance. On July 2, 2021, the Commission received a written response from the PAC. ETH. 1-10. The PAC disagrees with the Commission staff’s conclusion that the Independent Expenditure Report was filed late. The PAC also offers explanations for the other three potential violations. The Commission staff recommends that the Commission make the following findings:

1. The PAC was 22 days late in filing the Post Card Mania Independent Expenditure Report and impose a \$750 penalty. 21-A M.R.S. § 1019-B; 94-270 C.M.R. Ch. 1 §10(3).
2. The PAC failed to update its registration within ten days of changing its depository and impose no financial penalty. 21-A M.R.S. § 1052-A(3)(E).

3. The PAC's reported balance does not reflect its bank account balance. The Commission staff will work with the PAC to reconcile the account discrepancy consistent with the established compliance review practices.

LEGAL REQUIREMENTS

Reporting Expenditures. A PAC must report all expenditures to initiate or influence a campaign and include the payee, purpose, amount, and whether it was to support or oppose a candidate or referendum. 21-A M.R.S. § 1060(4). The PAC must also report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4).

Incorrect Account Balance. All PACs shall deposit all funds contributed to or received by the PAC for the purpose of influencing a campaign in a single account. 21-A. M.R.S. § 1054. The PAC shall also finance all expenditures to influence the election through the account. Id. All other expenditures made by the PAC must also be reported. 21-A M.R.S. § 1060(7). Accordingly, the account balance reported on the PAC's campaign finance reports should equal the committee's bank account balance.

Registration. A PAC shall register with the Commission within seven days of raising or spending more than \$1,500. 21-A M.R.S. § 1052-A(1). A PAC shall amend its registration within 10 days of a change in the information that PACs are required to disclose under this section. Id. Failure to register or amend timely may result in a fine of no more than \$2,500. 21-A M.R.S. § 1062-A(1). The Commission shall consider, whether the violation was intentional, the amount of financial activity, whether the committee intended to conceal its activity, and the level of experience of the staff. Id.

Independent Expenditure Reports. An independent expenditure that occurs between the 60th days before an election and the 14th day before an election must be filed within two days of the expenditure. 94-270 C.M.R. Ch. 1 § 10(3). A late report triggers the statutory penalty calculation. 21-A M.R.S. § 1020-A(4-A).

Incorrect Account Balance. All PACs shall deposit all funds contributed to or received by the PAC for the purpose of influencing a campaign in a single account. 21-A. M.R.S.

§ 1054. The PAC shall also finance all expenditures to influence the election through the account. Id. All other expenditures made by the PAC must also be reported. 21-A M.R.S. § 1060(7). Accordingly, the account balance reported on the PAC's campaign finance reports should equal the committee's bank account balance.

Receipt Retention. The treasurer of a PAC shall retain a vendor invoice or receipt stating the particular goods or services purchased for every expenditure in excess of \$50 to initiate or influence a campaign. 21-A M.R.S. § 1057(2).

Reporting Contributions. A PAC who receives more than \$50 in contributions from a person must itemize their contributions and include the person's name, occupation, place of business, and mailing address. 21-A M.R.S. § 1060(6).

ANALYSIS AND STAFF RECOMMENDATION

Incorrect Payment Amount

An independent expenditure report must accurately disclose the amount of expenditures spent to influence a candidate's campaign. 21-A M.R.S. §§ 1019-B(4), 1060(4). The PAC's Independent Expenditure Report, filed 10/16/2020, disclosed a payment of \$9,551.26 to Post Card Mania. ETH. 24. The three provided invoices (supported by the bank statements), show a total payment of \$10,436.39. ETH. 25-27. The PAC explains that it relied on the order summary (ETH. 10) for the total cost. ETH. 1. The order summary shows that \$9,551.26 was applied to the order and that there was a credit of \$885.13 on the account.¹ ETH. 10. Given this new information, the Commission staff accepts that the correct payment for this independent expenditure was the reported \$9,551.26. For these reasons, Commission staff recommends treating this issue as resolved, and not as a potential violation as originally indicated to the PAC. ETH. 14-15.

Late Independent Expenditure Report

An independent expenditure that occurs between the 60th days before an election and the 14th day before an election must be filed within two days of the expenditure. 94-270 C.M.R. Ch. 1 § 10(3). An expenditure is made when there is a payment, promise of payment, or the transfer of funds by one political entity to another.

¹ The PAC confirmed that the it has a credit with the vendor for that amount.

21-A M.R.S. § 1052(4). Any one transaction, may trigger the expenditure provisions multiple times (*e.g.* enter into an agreement to pay on one date and then make the payment on a later date), in those cases, the Commission staff has interpreted² the law to be that the expenditure is made at the earliest point [most often the agreement (whether it is legally enforceable or not)].

The PAC contends that it was not required to report the independent expenditure until the product was completed and the final payment invoiced, which occurred on October 14, 2020. ETH. 2. The Commission staff disagrees with this interpretation and factual presentation. The timeline for this expenditure is as follows:

The timeline shows that each invoice was promptly paid by the PAC and should have triggered the Independent Expenditure Report obligation. 94-270 C.M.R. Ch. 1 § 10(3). Whether the scale and scope of the expenditure changed between its initiation and completion does not retroactively change the expenditure date. In this case, the PAC was required to file an Independent Expenditure Report by 9/24/2020 and then amend that report based on the changes that occurred through the final version. This results in a late filing penalty as shown on the table below.

The Commission may reduce a penalty due to a valid emergency, error by staff, failure to receive notice of the deadline, and any other circumstances determined by the Commission to warrant mitigation of the penalty. 21-A M.R.S. § 1020-A(2). The Commission staff accepts that the PAC did not intentionally delay filing the report. The final expenditure, however, was significant and sought to influence several campaigns in Maine, which was ultimately disseminated during the last few weeks prior to the election. For these reasons, the Commission staff recommends that the Commission impose a \$750 penalty.

Failure to Update Registration

A PAC shall register with the Commission within seven days of raising or spending more than \$1,500. 21-A M.R.S. § 1052-A(1). A PAC shall amend its registration within 10 days of a change in the information that PACs are required to disclose under this section. Id. Failure to register or amend timely may result in a fine of no more than \$2,500. 21-A M.R.S. § 1062-A(1). The Commission shall consider, whether the violation was intentional, the amount of financial activity, whether the committee intended to conceal its activity, and the level of experience of the staff. Id.

In July 2020, the PAC changed its depository from TD Bank to Key Bank but did not update the registration to disclose the new account. The identity of the financial institution is not publicly disclosed on the registration, but the Commission staff uses the information for the purpose of conducting investigations. The failure to update the registration could have significantly delayed the Commission staff if an investigation were ordered.

The PAC explained that it changed banks because it had difficulty accessing certain transactions online that were necessary to complete its reports. The PAC was unaware that it was required to update its registration. The Commission staff accepts this explanation.

The Commission staff recommends that the Commission find a violation but impose no financial penalty. The public was not deprived of any information and no investigation

into the PAC was delayed as a result of this error. The violation, however, could have significantly delayed an investigation by staff.

Mismatch Account Balance

The PAC's reported end of year balance is \$29,238.79 but the bank balance is \$31,329.99. The discrepancy of \$2,091.20 is above the \$1,000 threshold that the Commission allows staff to administratively adjust without the Commission's approval. The Commission staff recommends a further review be conducted to reconcile the accounts.

The Commission staff routinely works with PAC treasurers to reconcile the discrepancies between reported and actual balances. This reconciliation process is done as part of the Commission staff's routine compliance reviews and generally does not result in matters being brought before the Commission. If Commission staff is unable to reconcile the accounts from January 1, 2019 through December 31, 2019 and from January 1, 2021 through to the present, then the Commission staff may request that the Commission authorize an administrative adjustment for the discrepancy.

Failure to Report TJ Maxx Expenditure and Retain Receipt

A PAC must report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4). The PAC must also retain a vendor invoice or receipt stating the particular goods or services purchased for every expenditure in excess of \$50 to initiate or influence a campaign. 21-A M.R.S. § 1057(2).

On or about 01/07/2020, the PAC bought two office chairs for \$210.98 for Rep. Dillingham's leadership office.³ The PAC agrees that it did not retain a receipt from TJ Maxx. The transaction was also not reported by the PAC. The Commission staff recommends that the Commission find two exceptions for the failure to maintain a receipt and the failure to report the expenditure. The Commission staff recommends no further action.

³ The PAC supplied a picture of the chairs and a brief summary of the transaction, which has not been reproduced here because the quality of the image would prevent meaningful copies from being provided.

Failure to disclose \$100 of contributions, deposited on 01/09/2020

A PAC who receives more than \$50 in contributions from a person must itemize their contributions and include the person's name, occupation, place of business, and mailing address. 21-A M.R.S. § 1060(6). The PAC reported a total of \$6,550 in contributions but the deposit for that day was \$6,650. The Commission staff recommends that the Commission find the omitted \$100 was an exception and take no further action.

Failure to Report 01/30/2020 Expenditure

A PAC must report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4). On 01/30/2020, the PAC made an expenditure to USPS for \$32, which was not reported in the April Quarterly Report. The Commission staff recommends that the Commission find this omission to be an exception and take no further action.

Incorrect expenditure amount for 05/07/2020 expenditure to Zoom

A PAC must report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4). On 05/07/2020, the PAC made an expenditure to Zoom for \$112.42. The 11-Day Pre-Primary Report lists the expenditure of \$112. The Commission staff recommends that the Commission find this inaccurate reported amount to be an exception and take no further action.

Failure to Report 07/01/2020 and 07/02/2020 Expenditures to Rumbleup


A PAC must report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4). On 07/01/2020, the PAC made an expenditure to Rumbleup for \$256. The PAC also made an expenditure on 07/02/2020 to Rumbleup for \$18. Neither were reported in the 42-Day Post-Primary Reports. The Commission staff recommends that the Commission find these omissions to be exceptions and take no further action.

Failure to Report 07/07/2020 expenditure to Daddy O S

A PAC must report operational expenditures that are not made for the purpose of influencing a campaign. 21-A M.R.S. § 1060(4). On 07/07/2020, the PAC made an expenditure to “Daddy O S” for \$45.88, which was not reported in the 42-Day Post-Primary Report. The Commission staff recommends that the Commission find this omission to be an exception and take no further action.

Failure to indicate contributions to candidates to support their campaigns

All expenditures must indicate whether they are to support or oppose a candidate. 21-A M.R.S. § 1060(4). The Commission’s website does this by providing a checkbox for the PAC to indicate the purpose of the expenditure, shown below:

The PAC failed to mark this box when it made \$400 contributions to the following candidates:

- Daniel Newman (9/18/2020)
- Michael Lemelin (9/25/2020)
- Gregory Foster (10/26/2020)
- Sawin Millett (10/27/2020)
- George Vercelli (10/27/2020)

This oversight is a common issue with filers that the Commission staff regularly corrects. The Commission staff recommends that the Commission find five exceptions for these omissions and take no further action.

Payment to Ryan Lorrain that was reversed on 12/02/2020

On 11/30/2020, Mr. Ryan Lorrain cashed a check for \$5,000 for his work for the PAC. The December bank statement for the PAC shows that the \$5,000 check was reversed on 12/2/2020. The PAC indicated that the check number for the December transaction is identical to the November transaction and that a bank error caused the check to be processed a second time and that the bank corrected the error by reversing the second transaction. The Commission staff accepts this explanation because the check numbers for the November and December withdrawals are identical. For these reasons, the Commission staff considers this issue resolved.

CONCLUSION

The Commission staff recommends that the Commission find that:

1. The PAC was late in filing an Independent Expenditure report and impose a \$750 penalty;
2. The PAC failed to amend its registration to reflect a new bank account but impose no financial penalty; and
3. That the Commission staff will work with the PAC to reconcile the account discrepancy consistent with the established compliance review practices.

I am writing in response to the preliminary findings of the 2020 audit of the One Maine Leadership PAC. Generally the findings are accurate and we accept them and will work to ensure mistakes of omission, wrong categorization, and inaccuracies do not happen again. The mistakes/discrepancies listed under the Exceptions section are presently being amended into our report filings.

We disagree with the preliminary findings in section IV Potential Violation. Specifically that of *Incorrect Payment Amount and Late Independent Expenditure Report (IE)*.

We received an initial invoice from Post Card Mania in September for the \$8,283.54 amount cited in the findings. This amount was the initial payment for design and design services. No mailer existed at that point it was just the initial design work. We did not know yet how many and which districts would ultimately receive an independent expenditure and therefore could not report the IE.

On October 14th we received what we believed to be the final invoice (see email attached) and the completed mailer. At that time I reported the IE in accordance with the 24 hour reporting requirement. I reported the total cost as \$9,551.26. I have included several correspondences with Post Card Mania indicating that until October 14th we were still designing and editing the IEs and that it was not finalized to be mailed until October 14th.

There is a discrepancy of \$885.13 between what was reported and what was paid. I am not sure why this occurred but I have included the invoice listing the \$9,551.26. I believe that when we divided the cost of the IEs among the intended recipients we mistakenly used the total number on the bottom right of the invoice and not the paid amount on the bottom left. This confusion I believe was in part a result of receiving several invoices while the mailer was in various stages of the development and us waiting until we had a final cost and product to file our report.

We did not report the IE in September when we received the initial bill believing we didn't need to report the IE until the product was completed and final payment invoiced which occurred on October 14th. The discrepancy of \$885.13 is a regrettable mistake in reading the invoice and we will amend our filings to ensure it is capture.

The third and fourth findings in Section IV, *Failure to Update Registration and Mismatch Account Balance*, we do not contest but wanted to offer some explanation for the change in account and its being out of balance. This occurred with the January deposit cited under exceptions in the letter to us. When I went to file the report the scans of the deposited checks were no longer available on the TD Bank website. So I was unable to list all of the donors associated with the money deposited. My ability to get these scans from the bank proved difficult and ultimately lead to the changing of accounts from TD to Key Bank. Not reporting that change was plain ignorance on my part as I did not realized I needed to report the change.

I believe that with the scans I will be able to get the account in balance and we are working on getting those scans from TD Bank to make that adjustment.

I accept full responsibility for the mistakes highlighted in the preliminary findings report though disagree with the findings associated with the IEs and filing dates in Section IV. I also believe the account can be balanced by looking into the January 2020 deposits.

Please let me know if I can provide any additional information and I look forward to working with you to address your findings.

I. Overview of Findings

The Commission staff requested the PAC's records on 12/08/2020. The records were provided on or about 01/31/2021. A request for additional records was mailed on 03/08/2021. The additional records were received on or about 03/22/2021. Upon completion of its review, the Commission staff found four potential violations and several exceptions. The Commission staff is recommending a \$1,000 penalty for these potential violations.

The Commission staff also recommends the Commission authorize an expanded compliance review of this PAC. Specifically, the Commission staff would look to obtain additional bank records from 08/31/2017 to 12/31/2019. The purpose of the additional review would be to identify errors, make corrections, and to resolve a \$2,000 discrepancy between the PAC's bank balance and report balance. After that review, the Commission staff may recommend additional financial penalties.

II. History of Committee

One Maine PAC registered as a political action committee on 08/31/2017. Representative Kathleen Dillingham is the Principal Officer and Mr. William Thompson is the Treasurer for the PAC. In 2020, the PAC raised \$102,432.00 and spent \$83,889.99.

III. Procedures

In the 12/08/2020 letter, the Commission staff requested the PAC produce the following 2020 records: (1) bank statements; (2) receipts/invoices for all expenditures over \$50; (3) documentation of any new loans or debts; and (4) records from ActBlue/Anedot or similar fundraising services.

After receiving those records, the Commission staff compared the provided records against the reported transactions for incorrect reporting. Specifically, the Commission staff reviewed the records for: omitted or duplicate transactions, failure to itemize contributions, prohibited payments, misuse of funds for personal enrichment in violation of 21-A M.R.S. § 1054-B, failure to keep records, improper contributions and other errors.

During its review of One Maine PAC, the Commission staff found that additional records would be required. On 03/09/2021, the Commission staff sent an email requesting the following:

- You provided a receipt for \$8,283.54 to Rocket Print and Mail that does not appear to have been reported nor shows up on the bank statement. Is this receipt associated with the PAC?
- Please detail the payment to Mr. Ryan Lorrain that was reversed on 12/2/2020.
- On 10/23/2020, the PAC reported \$1,000 in contributions from Anthem. Please indicate the date that payment was deposited.
- On 11/2/2020, the PAC reported \$1,000 in contributions from Charter Communications. Please indicate the date that payment was deposited.
- On 12/15/2020, the PAC deposited \$1,500. Please provide the deposit slip/check stubs that were deposited on that date.

The Commission staff received the PAC's response on 03/22/2021

IV. Potential Violation

After reviewing the records provided on 01/31/2021 and the additional records provided on 03/22/2021, the Commission staff found four discrepancies that would rise to potential violations of Title 21-A.

Incorrect Payment Amount. On 10/16/2020, the PAC reported paying Post Card Mania (a.k.a. Rocket Print & Mail) \$9,551.26 for mailers. The three invoices from Rocket Print & Mail, however, show the total expenditure to be \$10,436.39. The PAC's bank statements also support this \$10,436.39 payment. This \$1,040.56 discrepancy between the reported expenditure and actual expenditure is significant due to its proximity to the election.

The Commission staff recommends that the Commission find a violation of 21-A M.R.S. § 1004-A(4), which carries a maximum penalty of \$5,000. The Commission staff recommends a penalty of \$250.

Late Independent Expenditure Report. Also related to the payment to Post Card Mania, the PAC filed a 2-Day Independent Expenditure Report on 10/16/2020. The report, however, was due on 09/24/2020 because the PAC was invoiced for this expenditure¹ on 09/22/2020. This results in a late filing penalty as shown on the table below.

The Commission staff recommends reducing this penalty to \$750 for the late Independent Expenditure Report.

Failure to Update Registration. On 07/13/2020, the PAC closed its account with TD Bank and on 07/22/2020, deposited the funds into a newly established Key Bank account. The PAC, however, failed to file an amended registration with the Commission disclosing the location of the new account. 21-A M.R.S. § 1052-A(3)(E). The Commission can impose a penalty up to \$2,500. 21-A M.R.S. § 1062-A(1). The Commission staff recommends finding a violation but imposing no financial penalty.

Mismatch Account Balance. The PAC's reported end of year balance is \$29,238.79; however, the bank balance is \$31,329.99. The discrepancy between the accounts is \$2,091.20, which exceeds the \$1,000 threshold the Commission staff can administratively adjust without the Commission's approval. Absent the Commission's approval to administratively adjust this discrepancy, the Commission staff recommends that a further review is required to identify the discrepancies and reconcile the account.

¹ An expenditure includes a contract, promise, or agreement to make a purchase, payment, or anything of value for the purpose of influencing an election. 21-A M.R.S. § 1052-A(4)(A). The Commission staff has always interpreted the expenditure date for a transaction to be the earliest possible date within the definition of expenditure. Here, the PAC incurred the expenditure at least when it was invoiced, if not sooner.

V. Exceptions

After reviewing the records provided on 01/31/2021 and the additional records provided on 03/22/2021, the Commission staff found the following discrepancies that constitute exceptions:

- On 01/07/2020, the PAC made an expenditure to TJ Maxx for \$210.98 for the purchase of two chairs for Rep. Dillingham's office. This expenditure was not reported by the PAC in the April Quarterly Report and the receipt for the transaction was not retained.
- On 01/09/2020, the PAC reported receiving a total of \$6,550 in contributions, but the bank records show that \$6,650 was deposited into the account.
- On 01/30/2020, the PAC made an expenditure to USPS for \$32. This was not reported in the April Quarterly Report.
- On 05/07/2020, the PAC reported an expenditure of \$112 to Zoom, but the documentation shows the cost to be \$112.42.
- On 07/01/2020, the PAC made an expenditure of \$256 to Rumbleup that was not reported in the October Quarterly Report.
- On 07/02/2020, the PAC made an expenditure of \$18 to Rumbleup, that was not reported.
- On 07/07/2020, the PAC made an expenditure of \$45.88 to "Daddy O S" that was not reported.

The following \$400 expenditures to candidates were incorrectly reported as operational expenses in the October Quarterly Report:

Daniel Newman (9/18/2020)
Michael Lemelin (9/25/2020)
Gregory Foster (10/26/2020)
Sawin Millett (10/27/2020)
George Vercelli (10/27/2020)

VI. Conclusions and Recommendations

Based on the foregoing findings, the Commission staff recommends that the Commission find that (1) the 2-Day Independent Expenditure Report substantially misrepresented the expenditures; (2) the 2-Day Independent Expenditure Report was filed late; and (3) the PAC failed to update its registration to reflect the new bank account. The Commission staff recommends a penalty of \$1,000 for these violations. Lastly, the Commission staff recommends the review be expanded to reconcile the account discrepancy.
