- Re: Recommended Actions against Howard Patten and Timothy Keenan for Not Registering as Candidates

Duty to register as a candidate. Under 21-A M.R.S.A. § 1013-A(l)(A), candidates for state office are required to appoint a treasurer within 10 days of becoming a candidate. Within 10 days of appointing a treasurer, they are required to register as a candidate with the Commission. Registration is not difficult. They can register by filling out a simple online form (no login required) or use a paper form available on our website (attached). (For your information, sections 2-A, 3, and 4 of the paper form are optional, and Section 6 does not apply to most candidates.)

Registrations received to date. Most candidates are aware of the registration requirement through prior campaign experience or because they have heard about it from other candidates or the political parties. To date, 341 House candidates and 81 Senate candidates have registered for the 2022 primary election, along with 105 candidates for District Attorney and county offices.

Unregistered Candidates. Candidates who are enrolled in a political party were required to qualify for the primary election ballot by March 15, 2022 by filing nominating petitions with the Secretary of State. The Commission staff has diligently tried to get all 2022 candidates for legislative and county office to register by sending them notices and registration forms, and sometimes by calling (when phone numbers are accessible).

On March 7, 2022, Timothy Keenan qualified for the ballot as the only candidate in the Republican primary election for State Representative, District #132, which includes Biddeford. On March 14, 2022, Howard Patten qualified for the ballot as the only candidate in the Republican primary election for State Representative, District #151, which includes Kittery. The Commission staff sent three notices to them by U.S. Mail requesting that they register. The last two notices warned them of a possible \$100 penalty if they did not register. We left a voicemail message for Mr. Keenan on his cell or home phone, and a voicemail for Mr. Patten at his construction company. These attempted contacts are noted in the attached excel chart. The correspondence is also attached (all letters were sent on official Commission letterhead although some of the attached copies are based on electronic versions that do not show the Commission name and address). In spite of these efforts, Mr. Keenan and Mr. Patten have not registered.

Recommendation by Commission staff. The Commission staff recommends that you find that the candidates violated 21-A M.R.S.A. § 1013-A(l)(A) by failing to timely register with the Commission and assess a \$100 penalty against each of them, pursuant to 21-A M.R.S.A. § 1020-A(1). For your information (concerning precedents), at a March 25, 2016 meeting, the Commission found one candidate in violation for not registering, but assessed no penalty. The candidate attended the meeting and apologized. All candidates registered in 2018. Due to COVID, we did not take enforcement actions against any unregistered candidates in 2020.

It is possible that Mr. Patten and Mr. Keenan were asked to qualify for the primary election as "paper candidates" and the intend to withdraw after the primary election to be replaced by their party's nominee. We cannot confirm this, however. Regardless, they are required to register with the Commission as candidates and file campaign finance reports for the primary election by June 3 and July 26, 2022.

To request an exemption, complete the statement below and sections 1 & 5, have the form notarized, and submit it to the Commission.

Title 21-A M.R.S. Chapter 13: Campaign Finance Reports and Finances

Subchapter II Reports on Campaigns for Office

•••

§ 1013-A. Registration

1. Candidates, their treasurers and political committees. A candidate shall register the candidate's name and the name of a treasurer with the commission at least once in each legislative biennium, as provided in this section. A candidate may have only one treasurer, who must be appointed pursuant to paragraph A or B. For purposes of this section, "legislative biennium" means the term of office a person is elected to serve in the Legislature.

A. No later than 10 days after becoming a candidate and before accepting contributions, making expenditures or incurring obligations, a candidate for state or county office or a candidate for municipal office who has not filed a written notice in accordance with section 1011, subsection 4, paragraph A shall appoint a treasurer. The candidate may serve as treasurer, except that a participating candidate, as defined in section 1122, subsection 6, or a candidate certified in accordance with section 1125 may not serve as treasurer, except that the candidate may serve as treasurer or deputy treasurer for up to 14 days after declaring an intention to qualify for campaign financing under chapter 14 until the candidate identifies another person to serve as treasurer. The candidate may have only one treasurer, who is responsible for the filing of campaign finance reports under this chapter. A candidate shall register the candidate's name and address and the name and address of the treasurer appointed under this section no later than 10 days after the appointment of the treasurer. A candidate may accept contributions personally or make or authorize expenditures personally, as long as the candidate reports all contributions and expenditures to the treasurer. The treasurer shall make a consolidated report of all income and expenditures and provide this report to the commission.

§ 1020-A. Failure to file on time

1. Registration. A candidate that fails to register the name of a candidate, treasurer or political committee with the commission within the time allowed by section 1013-A, subsection 1 may be assessed a forfeiture of \$100. The commission shall determine whether a registration satisfies the requirements for timely filing under section 1013-A, subsection 1.
